- reports that there will be a new faculty of pharmacy at Waterloo, and we will need new communication materials and also look into including them in our council

- poses the question of whether or not we need to change our mailing address to Manitoba, since we are registered as a non profit organization there

CAPSIL Editor – C. Lui

- 24 pages in the last issue of the CAPSIL (that is the longest issue ever to be published)
- Will work on putting both the English and French version on the CAPSI National website
- Made buttons to be given to CAPSIL contributors as a "thank-you". Each school will be receiving a bag to distribute.

IPSF Liaison – H. Adams

- Notes that a student from Toronto will be participating in the WHO internship, and she would like to get sponsorship from CAPSI. H. Adams would like to discuss this issue further in future meetings
- Discussion regarding a "smoke free" environment for future CAPSI events:
 - o Comments made that as a health professional group, our events should be smoke free
 - Comments made that there are already laws in Canada that prohibits smoking in public places, and having a smoke free environment for CAPSI events would not be hard to achieve.
 - o A smoke free environment will be a position that CAPSI supports, not a rule that we will reinforce as that would be difficult
 - We will make CAPSI events a smoke free environment for all of our participants' comfort

- need to work on finding more pharmacies to accommodate students

Item 7 CAPSIL – Executive Contributions

- C. Lui proposes that each member of the executive council contribute a short article to every issue of the CAPSIL (3 per year)
- This is to help students be kept up to date about what their elected representatives are doing for them.

C. Lui

- Just a short paragraph is fine. However, if the situation calls for a full length article, please do so. C. Lui encourages us to exercise our own judgment.
- L. Bui comments that this is a good way of stirring students' interest in what CAPSI does, and also creates more transparency

Item 8 Competition Review

M. Berg

This discussion is intended to elucidate what worked, what did not, and what ideas for future improvements exist.

Compounding Competition

- a list of materials that needs to be prepared as well as a list of what the company will be providing will be helpful, as the University of Toronto had a hard time trying to gather materials at the last minute
- many students want to participate, however due to a lack of markers, not everyone could
- UBC comments that they invite their teaching assistants to help mark the competitions, and marking is not a big burden
- F. Malik suggests getting a licensed pharmacist to help mark the competitions. The pharmacists who helped them received a CEU credit from the pharmacy association
- J. Ramji comments that they invited a professor and his team that specialized in compounding to help mark
- B. Liao comments that 16 teams divided into 2 days between 4 judges. This way every judge had 2 teams to mark and marking was done efficiently

Patient Interview Competition

- C. Johnston comments that none of the students knew what the medication in question was and everyone had a hard time at the competition as a result of that
- B. Currie states that students did not have time to fill out the documentation sheet and were confused as to what they were to do with it.

OTC Competition

- Council members feel that the competition regulations should be made uniform across Canada. E.g. decide whether or not students are allowed to know the product before the competition
- B. Currie suggests making a to-do list for all senior representatives, so that nothing will be missed and everyone will be doing the same thing
- L. Bui suggests giving schools a list of possible products so that local representatives can prepare them ahead of time. At UBC, they had no products and they had to make it up

 C. Johnston comments that having a standard protocol across Canada will help competition winners when they compete on the national level because they will know what to expect.

BIRT we raise the Ratiopharm hand washing discussion now. O. Famuyide/ F. Malik Carried

Item 9 Ratiopharm Operation Wash Up

The purpose of this discussion is to prepare for meeting with Ratiopharm.

Memorial

- Great feedback from students, great materials. Everyone enjoyed it very much

Dalhousie

- Had a hard time getting schools to agree to do the hand washing program. But the schools that did agree had a good time.

Laval

- it was a good experience, and they received excellent feedback,
- lots of schools wanted to participate
- translation of the video was poor (bad timing, incorrect words, subtitles only in English)
- also need more materials

Montreal

- there was a high demand
- translation of video was poor
- Raised the concern that there are nurses who do these kinds of hand washing programs, perhaps we should look into programs that are more specialized for pharmacists e.g. diabetes, STI's

Toronto

- had a hard time finding schools to be interested in this program
- A couple of schools stated they had similar programs. And people in general were not receptive
- Suggestion: delegate the responsibility of finding schools to the students in charge of each hand washing program

Manitoba

- Excellent feedback
- needs more materials
- There is even one grad student who will be doing this because she feels it is an excellent program.

Saskatchewan

- easy to implement Operation Wash Up
- needed more supplies
- It was broadcasted at their news station so that parents know what their kids are learning in school.

Alberta

- not enough supplies
- Presentation was 1 hour long, and seems too long for the kids to stay attentive. There is lots of dialogue, but not enough visual stimulation.
- There are long waiting times required for the washing hands demo
- Suggestion: give children a colouring sheet so they have something to do while they wait for their turn

UBC

- no presentations yet, have only introduced it during PAW
- They already have a strong community outreach program such as Katy's Kids, Tobacco Alert program and High school Outreach.
- They will be starting Operation Wash- up this coming September
- O. Famuyide suggests to D. Lee to come up with a standard description of Operation Wash up that can be distributed to schools.
- D. Lee states he will draft up a fax.

Item 12 Budget (Current and Future)

B. Liao

- Currently CAPSI is in an excellent financial position.
- Although we find ourselves with a budget deficit of \$10,684, we still have an extremely comfortable cushion of approximately \$30,000 surplus that we can decide how to use so that we may benefit our members best.

- We are currently looking for a new accounting firm to do our taxes as the previous accountant will no longer do it at a discounted price
- Suggestions include offering the account some ads in the agenda or seeking a bigger firm for a cheaper price
- Bruce will look at the options and report back to us

O. Famuyide proposes to set aside \$150 as a cash prize for the best post on the CAPSI forum:

- the Website Committee will decide the criteria/eligibility of the winners
- the \$150 will be divided into 3 prizes of \$50 each

BIRT CAPSI National allocates a \$150 reward for website submissions. O. Famuyide / F. Malik Carried

Discussion regarding setting aside a budget for international projects:

- B. Currie suggests setting aside a budget for all international projects/initiatives/outreaches
- Mention of the book drive; CAPSI council was purchasing books with the funds from our members' registration fees, however our members were not aware of this
 - o H. Adams suggests to set up a budget for the book drive, then publicize it to our members
 - Some members feel that CAPSI should try to think of ways to help/benefit
 its members first, so this money used to buy books may be better used if it
 was used to send members to the IPSF conference

BIRT CAPSI National tables this discussion. A. Somers/ L. Bui

Carried

A. Somers proposes to have a budget to continue sending the President and President Elect to the APhA-ASP Conference each year instead of the CSHP conference in January:

- it is a great learning experience and would benefit CAPSI very much
- the benefits include article exchanges, and educational program exchanges
 - o e.g. vaccination programs
- there is a lot we can learn from how they operate their student government
- They had 2000+ students attending the conference, and almost all of them attended the AGM. Again, we can learn from this
- sending 2 council members will represent CAPSI in a better light
- M. Berg adds that sending one member only is not enough, it is nice to have the President clarify points during the meetings if necessary
- Sending the President and President Elect also helps to ensure the continuity of our relationship (e.g. between the President Elects)

- There were concerns that going every year may not be beneficial as there is only so much you can learn, however M. Berg comments that each year you can build on what you already know and learn more that way.

BIRT CAPSI National continues to send the president and president elect to the APhA-ASP Conference each year.

Item 13 Pan American Regional Symposium

V. Masson

- the local Pan-American Regional Office (PARO) of the International Pharmacy Students Federation (IPSF) holds a conference every year
- V. Masson feels that we need to increase CAPSI's involvement within the PARO.
- Suggests that we send either the IPSF Liaison of the Student Exchange officer to the conference on an annual basis
- The conference is 4-5 days and there are meetings to attend
- It would be beneficial to get to know PARO and for them to get to know CAPSI
- Registration costs are approximately \$300 and the transportation is approximately \$600, so the total cost would be approximately \$1000

BIRT the Student Exchange Officer attend the PARO conference on a yearly basis.

Item 14 Translation Committee

C. Lui

- translating 3 issues of the CAPSIL is a lot of work for one student
- the AGM information and competition information also needs to be translated
- the student who translated the CAPSIL last year proposes that we put together a committee of 3-4 students to translate everything for the entire council
- Another option is to go to a translation group to do it

- o E.g. Heritage Canada has a grant that will pay up to 50% (or up to \$5000) for the translations because they want to promote bilingualism
- However with Heritage Canada we must hire a professional and not use a student
- o Generally, companies will charge \$0.25 per word, this means \$4100 per issue of the CAPSIL, so even if we do get the grant from Heritage Canada it is still a lot of CAPSI council to pay
- F. St. James comments that he knows someone who might be willing to translate for CAPSI
- D. Boivin also knows someone who is willing to translate for 3 issues of the CAPSIL, 3 competitions (of 3 pages each for a total of 9 pages) and 2 PowerPoint's for the AGM all for \$5000 (that works out to be \$0.10 per word)
- C. Lui states that she would like to go for the cheapest option, however, that means turning to students.
 - o She feels that students are not always reliable (in terms of accuracy) and if the budget allows she would like to go with a professional group
 - o M. Helene adds that translation is hard work and we should try to get a professional to do it if possible
 - o J. Therrien adds that you can work with deadlines when you work with a professional and there is more accountability with the job
 - O. Famuyide comments CAPSI has previously hired a company to do their translations however the translation was poor.
- V. Masson states that at Pharmacists without Borders, the professors give translation assignments to the students as homework. She has offered to look into it.

Directive: Cynthia will look into finding a professional translator for the CAPSIL and other CAPSI translations, including the website.

Item 15 Honorary Life Members

A. Somers

- honorary life members (HLM) are exceptional individuals who have in one way or another contributed to CAPSI in a significant manner
- in order to be named an HLM, a person must be nominated by a council in one year, then accepted by the following council in order to ensure the continuity of dedication
- this year's council must decide whether or not to accept Larry Pereira as an HLM
- benefits of being an HLM:
 - o recognition at PDW and on the CAPSI National Website
 - o copies of the CAPSI agenda
 - o access to the CAPSIL

- A. Somers moves to accept Larry Pereira as an HLM
 - Larry Pereira has ensured that CAPSI events were funded adequately by Wyeth
 - He has been an amazing mentor to Adam Somers, Carey Lai, and other past presidents
 - Larry Pereira goes above and beyond what most people would do for CAPSI
- UBC is strongly in favour
 - o They have dealt with Larry on a regular basis.
 - o If they ever need anything Larry would be sure to help
 - o Wyeth has sponsored UBC's website for 2 years now
 - o He tries to make everything easier for the UBC CAPSI council
 - Being an HLM would be a great way to honour his contributions to CAPSI National and Western Canada
- M. Berg passes the gavel to O. Famuyide
 - o M. Berg comments that Larry Pereira is a wonderful person.
- M. Berg takes the gavel back from O. Famuyide

Item 16 Non-voting CSHP student representative on CAPSI council M. Berg

- At PDW 2006, the CSHP proposed that the CSHP Student Representative sit in on the CAPSI meetings as an official observer without any voting powers.
- They will be attending PDW and CPhA and will have access to the minutes. However they will not be sitting in on in-camera discussions
- CSHP and CPhA are the two main groups that CAPSI has dealt with historically and realistically
 - Having the CSHP member will help to facilitate discussion between the two groups (that is a benefit)

BIRT CAPSI National accepts a CSHP student to sit as a non-voting observer member on the CAPSI National Council.

A. Somers/ J. Therrien

Carried

- sales over the past year have gone well, however there are some important issues need to be addressed at this point in lieu of our meeting with Apotex on June 5
- Who should we offer this to? Every year? Or just a single year?
 - o CAPSI would prefer to open it to all years, however Apotex would like to keep it an offer to only one year
 - o H. Adams comments that 3rd years will appreciate it most
 - o J. Ramji comments that from a sales point of view, it would be best offered to 4th years as they will be going into practice
 - o L. Bui comments that it would be useful for 3rd and 4th years, as the younger students would not have as great a need for them
 - o J. Therrien notes that some students did not want to use it in their 1st or 2nd year, but wanted to purchase it now for their 3rd and 4th years in case the iPharmacist coupon was not coming back in subsequent years

A quick survey of which year each school feels it should be offered to:

Memorial: 3rd year Dalhousie: 2nd year Laval: 3rd year Montreal: 2nd year Toronto: 3rd year Manitoba: 3rd year Saskatchewan: 3rd year

Alberta: 2nd year UBC: 3rd year

- Conclusion: we will try to promote it for the end of 2nd year.
- other concerns regarding the iPharmacist program:
 - o there have been delivery concerns where the iPharmacist was left outside on the doorsteps of student's homes
 - need some way of ensuring that only CAPSI members will receive the ONE coupon that our members know it is not transferable to other students
 - Some coupons were put on e-bay. This will jeopardize the iPharmacist program we have with Apotex
 - someone found a coupon and got an iPharmacist however she is not a CAPSI member
 - suggestions have been put out to use the student number/CAPSI membership number as a means of ensuring that only one CAPSI member gets the discount

- however, Apotex has decided against the membership number, but we will try to propose it to them again
- suggestions have been put out to stress to the students during the promotion/announcements that they will only receive one coupon, and if they do not intend to purchase an iPharmacist they should not pick it up, and that if a student loses their coupon, they lose it and they cannot have another

o annual renewal fee:

- some students were deterred from purchasing the iPharmacist because of the annual renewal fee
 - Point of clarification: if a student does not renew the iPharmacist, they will not lose their old data. However we should not advocate the use of outdated data, especially for new drugs. This is unprofessional and we would be liable)
 - there was a suggestion to waive the renewal fee for students, and charge the renewal fee as usual once they have graduated
- There was confusion as to when the date for the renewal fee begins.
 - It is actually when you order it, and not when you log in online
- o Computer program compatibility:
 - The iPharmacist is not compatible with Mac computers
 - Students had to buy another program at \$400 to use the programs on iPharmacist
 - Perhaps Apotex can look into developing a Maccompatible version
- o the iPharmacist website:
 - it is hard to find the French version on the English website
 - suggestion: make the link more visible
- o training manuals:
 - some students have expressed concern that there is a lack of a proper training manual and the iPharmacist program as well as the PDA was not user friendly despite the online help
 - suggestion: send an Apotex representative to the schools to provide a training session
 - E.g. like a lunch time lecture. This will educate the students as well as help to promote the iPharmacist program

- some students would like to have a sturdier case to protect their iPharmacist

- other Apotex-related concerns
 - Apotex backpacks
 - Some are falling apart: seams ripping, straps coming out after a few months
 - They are under warranty if it is manufacture defect, but not for normal wear and tear

- I. Theriault-Dube is present to give us PDW 2006 wrap -up
- PDW 2006 committee reported that there were no unexpected expenses and they have a balance of \$21, 327.28
- They had huge sponsorship, especially from Shoppers Drug Mart and Apotex
- Biggest expense was hotel and food, no bargaining could be done
- They cut a cheque of \$2000 to CAPSI (as they took a loan from us)
- suggestions for future PDW planning committees and CAPSI:
 - They will be putting together a binder to pass down to each PDW Planning committee, complete with contacts/partners/email addresses, planning tips, schedules
 - This binder will be added to by each PDW committee, to make it more complete

Winnipeg

Hotel

- the planning committee advised us to be sure to book under PDW 2007 to get discounted room rate
- there will be 2 hotels
- Transportation will run from both hotels
- Take note: the Delta Hotel is attached to the convention centre. The York Hotel is not.

Registration

- The max capacity is 850.
- Total spots for CAPSI committee/drug representatives are 50. (therefore 850-50=the number of spots left for delegates from each school)
- If more sponsorship becomes available, planning committee may be able to redistribute a few more spots to each school
- They are thinking of using online registration at karelo.com
 - o There will be 850 passwords, and each person will receive only one password

- o Take note: they only accept credit card
- o Local representatives will be responsible for distributing passwords.
- Unused passwords will be mailed back to planning committee and redistributed to other schools
- Local representatives will also be able to know who is registered because there will be mandatory fields in registration form, including email addresses
- o Cost of using this online service is \$6824
- planning committee emphasizes that they have put in a lot of effort to push the educational aspect of this conference, and invested a lot in speakers
- They want the conference to be available to more students, and have created the "Day Registration" option.
 - o For \$65, students can participate in all speaker sessions, but this will not include food, hotel, or any social events
 - The faculty at University of Manitoba have already considered suspending classes so that all students will be able to attend
 - o "Day Registration" will account for approximately 125 delegates, this is on top of the 850 delegates mentioned earlier
 - o These spots are mainly for students at the University of Manitoba.
 - The planning committee has received a lot of support from their students and they would like this "Day Registration" option to be their way of saying "thank you"
 - The conference rooms are massive and will be able to accommodate everyone
- they comment there may be a \$10 increase in registration fees if sponsorship doesn't come in

Schedule

- There will be a change to the schedule. CAPSI elections should be at least 2 hours. Currently it is only 1 hour. It will be changed to 9:30am to 11:30am
- there are concerns that delegates will not attend the elections due to the health fair, however there are no other rooms available except on Friday at 9:30am
 - o council members suggested that we should encourage delegates to attend elections, and reassure them that the health fair is on until 2pm
 - o also discussion to make elections mandatory for everyone
 - However the representatives at the health fair will not be pleased as no one will be able to attend the health fair. It has already been confirmed with the sponsors that the health fair will be between 9am to 2pm
- the auctions will be held at the Manitoba-style "Social"

Social Events

- Note on Manitoba style social: gambling is not mandatory. The money is also not real. The "money" won is exchanged for raffle tickets.

<u>Budget</u>

- There was a problem with the finance officer and they have asked him to step down.
- They still do not have a finance officer. However they have a committee that is helping out right now.
- Any sponsors who are Bronze level and up, will not be delegated to another contact on their committee, however any sponsor who is below the bronze level will probably be delegated to another member

 - o this is due to the fact that PDW 2007 will not be changing conference rooms
 - o PDW 2006 committee suggests that PDW 2007 committee provide a detailed list of what they need to the A/V company and to make sure that the company will provide it, and to inquire as to how many technicians they will provide and how many hours they will be working
- there is no budget for security, they will find a quote for that
- They also need to look into a budget for the competitions.
- D. Lee will be the contact for this after he receives his portfolio

Health Fair

- planning committee will follow up on who is participating in the health fair

Apotex's sponsorship

- They will be covering the cost of the opening gala.
- They have requested that a new level above Platinum be created so that they can be more distinguished e.g. a Diamond level
 - This is due to the fact that they are contributing a great deal more than Novopharm
 - O PDW 2006 committee comments that for their conference, Apotex sponsored a great deal more than Novopharm, but the Novopharm closing banquet was a great deal more spectacular than the Apotex opening banquet. They suggest the PDW 2007 committee to strive to make the Apotex banquet more spectacular because they are donating a lot more
 - o Last year at PDW 2006, Apotex gave \$55,000 which is significantly above the \$27,000 from the next highest sponsor)

- o M. Berg suggests they open a new level of sponsorship to Apotex and also extend this same courtesy to Novopharm.
- o There is concern that if there is no new level of sponsorship, PDW 2008 may lose out on Apotex as a sponsor for their conference

Item 7 Guy Genest Scholarship

S. Baines

- [Gavel is passed back to M. Berg from O. Famuyide]
- In general, the Guy Genest Scholarship topic generated a lot of discussion and council members had a lot of different opinions about this award.

Discussion

- Guy Genest is an Honorary Life Member
- The concept of creating a scholarship at each school that would be a joint CAPSI National/CAPSI Local/ Wyeth venture in honour of Guy Genest was accepted by council earlier this year
- S. Baines comments that what Guy Genest does behind the scenes for CAPSI is truly exceptional, and immeasurably helpful
- S. Baines states that all faculties are very supportive of this award (however UBC will not be participating as they have similar award already)
- He would like this award to be distinct and prestigious, not just "any other award"
- the scholarship will consist of:
 - \$500 cash: \$100 from CAPSI National, \$100 from CAPSI Local, \$300 from Wyeth
 - o a plaque (suggestion by A. Somers)
 - S. Baines suggests making a plaque for display at the school. If there is enough sponsorship the student can have a plaque as well
 - Others feel that something even more prestigious than a plaque can be given out
 - o Public recognition:
 - H. Adams suggests presenting the award to the recipient at an event at PDW where all delegates attend
 - This brings the question: should we also cover the transportation costs of these individuals to PDW?
- We need:
 - 1. a name for the award:
 - Focus on passion. This is because Guy Genest exudes a lot of energy (passion for the profession of pharmacy)

2. recipient criteria

- members feel that a nomination form should be used
 - i. uniformity of the criteria:
 - There is concern that uniform criteria across
 Canada may conflict with similar awards at the schools
 - o O. Famuyide states it is important to keep criteria uniform across Canada

ii. Passion is an important criteria:

- A. Somers comments this award should be different from all other awards due to the passion factor that will be considered: it is easy to get involved but not everyone is passionate. It is important to have passion in the criteria and passion in the name
- J. Piszczek comments that passion is qualitative and hard to measure, and hopes that criteria will measurable
- Concerns that if passion is the criteria, that the award cannot be awarded every year because there may not be someone who is passionate enough to qualify
- S. Baines states that the award should be given out every year due to sponsorship issues, e.g. if only 4 out of 9 schools award this scholarship, the sponsors may not want to sponsor the scholarship
- o B. Currie states that if this award is given out every year but to someone who is not worthy, then the prestige of the award will be lost
- o A. Somers states that in every year, there is always someone who does a lot in the school
- There is also concern in the council that this award will be given to students who are always "in the limelight" and not to students who are quieter in the student body

iii. selection/nomination committee:

o B. Currie comments that the selection committee for that school will know when someone is passionate, so perhaps institute a testimonial application

- There is concern that if everyone in a student body feels that one person will win the award, no one will write the testimonial because they think someone will write on eventually
- There were suggestions for someone "nonbiased" to nominate the candidate, such as the local CAPSI representative
- S. Baines emphasizes we shouldn't exclude student nominations
- L. Bui states that at UBC the application is as follows: 2 letters of reference, a letter of intent, and a list of volunteer hours

iv. Eligibility:

- Everyone agrees the recipient must be a CAPSI member
- This award will not be geared toward a certain year level (this will also alleviate the burden of not having a suitable candidate)
- CAPSI council members should be eligible for this award
- The award can be given to the same person in consecutive years

BIRT the decision of the name and criteria of this award be moved to an ad hoc committee.

A. Somers/ D. Boivin Carried

- The Criteria Committee will email their ideas for approval by the council
- the committee will consist of:
 - S. Baines (Vice President of Interdisciplinary Affairs) as chair, A. Somers (past president), J. Piszczek (Vice President, Communications), D. Boivin (French-speaking representative) and B. Currie (English-speaking representative)

BIRT we close the discussion of the criteria of the Guy Genest Award. A. Somers/ B. Liao Carried

- further discussions on the application process:
 - o there is concern that if a student writes a nomination letter it will not be weighted as heavily as a letter from a dean or head of CPhA (as examples)
 - o D. Boivin suggests a letter of reference, fill in a form, plus a list of 10 signatures

- O S. Baines stresses that the reference letters can be written by anyone; there is to be a minimum of 1 reference letter, but additional letters are fine as well
- o F. St. James suggests that even a patient or the applicant's employer can write the reference letters
- J. Piszczek feels that reference should be made by a faculty member and a peer member because a peer member may not understand the definition of professionalism
- o B. Currie adds that a peer reference focuses more on the applicant's personality, so it is important to also have a professional view from the faculty or employer etc.

Item 3 CSHP Advocacy Campaigns: Management Leadership and Experiential Training in Hospital Pharmacy

1st Advocacy Campaign: Management Leadership

- Representatives from CSHP stated that they are lacking leaders in hospital pharmacy, be it managers or directors, due to lack of leadership training for pharmacists, and therefore, people from other fields are being hired.
- Some people feel that you don't need to be a pharmacist to lead a pharmacy department.
- Others feel it's unfortunate there are no leaders who are pharmacists.
- CSHP's position statement: promote that all leadership positions be pharmacists if it involves leading a pharmacy department
- This is a pattern that is seen in nursing and other professionals, and CSHP feels that pharmacists should be leading the departments
- therefore we need to train our pharmacists so that they do not shy away from this leadership role
- CSHP has formed a committee to look into developing training for pharmacists
- They hope that CAPSI would promote and agree with their ideas
- We would like to see a summary article of their directives and position of their ideas

- C. Lui will work on this with the CSHP representative, and she will put an article in the CAPSIL

2nd Advocacy Campaign: Experiential Training

- CSHP's position statement was supported by CAPSI previously in 2002 on the entry level Pharm D degree. It states that CSHP is not in support of the conversion of the B. Sc (Pharm) to entry level Pharm. D
- CSHP is not changing their position; however, it seems that entry level Pharm. D will be implemented anyway.
 - o They have sent out a letter of their position to various stakeholders and have received some response
- Hospital pharmacists make up 15% of all pharmacists but look after 50% of the experiential training in the field; CSHP feels that the parties involved in planning PEP need to keep this in mind
 - Hospital pharmacists need to and want to take care of their patients, however if they need to do so much training, the patient care may be compromised.
 - o Student training may be compromised also
 - o Some hospital pharmacists feel that they may need to say "no" to training more students, especially since there is a pharmacist shortage
 - O How this relates to the entry level Pharm D. Program: if the B. Sc (Pharm) and entry-level Pharm D. happen concurrently, then hospital pharmacists will have to train both groups of students, which will be an extra burden on hospital pharmacists
- CSHP states that hospital pharmacists need more funding for more human resources to provide good training for the pharmacy students. They want to do the training properly with appropriate staffing.
 - CSHP explains that hospital pharmacy gets their funding from the Ministry of Health, and education and training gets funding from the Ministry of Education
 - However, the catch is hospital teaching does not receive funding from the ministry of education, and therefore there is inadequate funding, as the funds from the Ministry of Health are intended for non-training purposes first

Item 4 Hospital Pharmacy Student Award

- recommendation to CSHP: move the deadline to the end of September instead of end of August; this will allow for further promotion of the award and allow students to apply to be eligible for coming years
- the award ceremony attendance at PDW was better than last year, but CAPSI will continue to get more people to attend

Item 5 National CSHP Mentorship Program

- this issue was raised with the CSHP council previously by CAPSI, to see the possibility of implementing a National CSHP Mentorship Program
- CSHP has received feedback from student representatives and they learned that every province has some sort of mentorship program already, therefore they feel there is no need to add another program
- M. Berg states that there are indeed programs available but the capacity is small and some students are left out
- CAPSI council suggests that CSHP can try to increase the visibility of these programs so that students will know about them
- CSHP replies that every province has different programs and it is structured differently e.g. length of time
- A. Somers states that schools across Canada have very different PEP programs, however they are not starting to make it uniform
- M. Berg states that students should not just see a "flash" of the hospital program but actually be able to develop a relationship with their mentors, he suggests that CSHP provide a list of available mentor programs in the different provinces and send this to the Senior Representatives at each school
 - o The Senior Representatives will then distribute this list to the students.
 - o CSHP will look into this and let us know
- There is also suggestion to put a link of these programs on the CAPSI website with the contact information (CSHP and local Senior Representatives)

Item 6 CSHP/CAPSI Student Symposia

- The symposia was previously only open to 2nd years, but now it will be open to all years

Item 7 CSHP Student to Sit on CAPSI Meetings

- CAPSI extends the invitation to CSHP to select a student to sit in on our meetings at CPhA, PDW, and videoconferences
- CSHP be responsible for reimbursing this observer member
- CSHP will pass the information to Justin (their student representative)

Item 8 Bill 102

- CSHP national has not been directly involved with this
- However, the Ontario branch of CSHP wants to print out a draft position statement: they are supportive of Bill 102
 - This is due to patient reimbursement, benefits to the hospital formularies, and government recognition/representation for pharmacy
 - o CSHP will send us the Ontario branch position statement

Item 3 Operation Wash-Up

- M. Berg summarized some general feedback from the council regarding Operation Wash-Up:
 - o Overall the presentation was very well received
 - o some councils had a hard time finding schools willing to participate
 - o poor translation of the video into French: poor timing, poor use of vocabulary, no subtitles
 - o need more materials
 - Presentation was 1 hour long, which may be a bit too long for the children to stay focused, there is a lot of dialogue and not enough visual stimulation, and long waiting times for the children to wait for their turn to wash hands.

local school comments:

- o British Columbia:
 - UBC will be starting Operation Wash-Up in September
 - It will be a part of their community outreach efforts
 - It is the responsibility of their Community Education Coordinator
 - They had one presentation during Pharmacy Awareness Week in the Student Union Building

o Alberta:

- Response was good, presenters liked it a lot more than other programs
- They did 2 presentations during Pharmacy Awareness Week and all schools they contacted wanted to have the presentation, however there were not enough supplies for all 175 students

o Saskatchewan:

- The presentation was showcased on the evening news
- Ratiopharm states this is excellent as they need justification to give the funds/materials for this program
- University already had a contact list of schools so CAPSI representatives did not need to research schools to contact
- They need more supplies

o Manitoba:

- They ran out of supplies; they received 6 packages and were all used up (this includes 2 French packages)
- All presentations went very well
- TV stations were interested in covering the presentations however a time could not be arranged

o Toronto:

 Did 3 presentations, they had problems finding schools to participate as some schools said they already had similar presentations done • 4th year pharmacy students interested in doing this for their SPEP

o Laval:

- Many schools wanted to participate, and many volunteers wanted to help with this presentation
- However they could only present at 1 school due to the large numbers
- French translation was not good, the children were distracted by the errors

o Montreal:

- Other faculties do these sorts of presentations also, suggests looking into a presentation that is more geared towards pharmacy students
- French translation was poor
- Feedback was good

o Dalhousie:

 Schools were worried about having media in their schools so response was small

o Memorial:

- Excellent response
- They still have some materials left over, so thinking of using it for future presentations
- Teachers enjoyed it very much, they would like more presentations

feedback from Ratiopharm:

- o the translation is being re-dubbed right now
- o they will continue to work on this Operation Wash-Up Program before starting any other programs
- o they suggest CAPSI National to be in charge of all supplies and divide it between the local universities
- o D. Lee will gauge the demand for each school and give an estimate of how many supplies we need, and will send this to Ratiopharm
- o It is possible for them to increase the quantities of supplies
- o Ratiopharm feels that a colouring book is a good idea
- o They will look into the possibility of sending out a media package so that we will be able to learn how to deal with them
- o Ratiopharm also suggests that we share the materials that other schools don't use up. E.g. senior representatives who notice they are not using their materials can send an email to the group to see who needs them

Overall, Ratiopharm was very happy to hear our positive feedback and our suggestions for improvement.

Item 3 Review of CPhA Campus Tours

- Memorial:
- very well attended
- online ordering was good
- some students did not receive their CPS until very late

 Confusion: some students thought e-CPS was a software and not online.

- Dalhousie:

 with the pre ordering, the attendance was much better, but the problem was that everyone ordered everything possible and not just the books they needed

- Laval:

- had a huge attendance
- many students registered to CPhA
- used both the electronic and paper ordering for books

- Montreal:

• went very well, pre ordering was great, good attendance

- Toronto:

- not pleased with CPhA campus tour:
 - They already have a book sale and they sold CPhA books to raise money. However that is no longer possible
 - they do not have room to store the boxes of extra books
 - it is inconvenient for them to ship the books back to CPhA because they need to drive to the postal office
 - they felt that the CPhA representatives were not as polite as they could be, did not help out as much as expected, and arrived at the last minute
 - overall the campus tour went well

- Manitoba:

- They were not aware of what was expected of the local CAPSI representatives and there was a lack of effective communication with the CPhA
- When the CPhA representatives arrived they were on edge
- The local representatives did not have a good experience working with CPhA representatives
- Pre-ordering is a great idea
- The actual tour was great
- The books did not arrive until the afternoon of the tour, and the senior representatives did not know that they were coming in; therefore when the CPhA representatives asked for the books, the local representatives didn't know where to find them
- It would be best if the books could arrive earlier
- A few students ordered books they didn't need and found the return process to be complicated
- Leftover books were picked up by the courier

- Saskatchewan:
 - Professors liked that it was pre ordered so they knew their students were getting the books.
 - Many students were under the impression that they were to receive the CPS at the tour.
 - Some students did not know that you had to order the CPS separately even though they were signing up for CPhA membership.
 - Some students received the English CPS instead of the French
 - Some students received their CPS very late

- Alberta:

- Campus tour went well
- Books were lost on campus through the campus mail system.
- Some books arrived and others did not
 - Perhaps send the books earlier so if they get lost the local representatives can track them down
- book returns were done by Purolater: they came to campus to pick them up
- also suggested the possibility of having tracking numbers so the local representatives can check the status of the books
- British Columbia:
 - they delegated the tasks to Marguerite Yee (faculty advisor) and Jinny Cheng (former Vice President Education)
 - Pre ordering was easy
 - Big line up for picking up of the books.
 - Many students' CPS arrived late (in December) and that was inconvenient because they needed it for exams. F. Huang still has not received her CPS. It is important for students to receive their CPS early because they need it for their classes

Item 4 Local CAPSI-CPhA Campus Tour Representative M. Berg

- The CPhA have requested that each local council nominate a campus tour representative to act as a liaison between CAPSI local and the CPhA Campus Tour to coordinate and facilitate their annual membership drives, room bookings, and books sales
- some members of CAPSI council feels that this is unnecessary as the contact person is the Senior Representative already, and it should be kept that way; there is no need for another position on council just for that one job

- J. Ramji comments that if the senior representative is not from school area, it may be easier to have someone else from the town to be the contact person
- Council members propose to give them a list of contacts
- Others comment that if we have a Campus Tour Representative, it would be fair that they have a CAPSI representative for us
- There is mention that having a CPhA representative allows the senior representative to have more time to take care of other tasks
- It will be up to the local senior representative who they want to delegate to be this contact person.
- M. Berg will address to CPhA that we will not perform the tasks that are their responsibilities e.g. collecting memberships
- Booking rooms is ok, but not unfair work, or making sure that the books arrive, etc.
- Some concerns: they are getting rooms booked and food ordered, what else do they need help with?
- The general consensus: room bookings and food ordering is OK. Anything else is not.
- J. Ramji comments that the local representatives already have enough to do for Campus Tours, and they are not able to be handing out books and taking in information forms
- J. Lee comments that the CPhA t- shirts are cute.

Item 5 Pharmacy Human Resources Study

O. Famuyide

- the first inaugural meeting of the National Advisory Committee's Pharmacy Human Resources Study took place in Ottawa in April 10-11th
- they invited a representative of CAPSI to sit in the meeting
- A. Somers was present to represent CAPSI at the meeting
- The study has 3 main focuses:
- International pharmacy graduates and their obstacles
- Pharmacy technicians and the regulations governing their occupation
- The evolving role of the pharmacist
- A. Somers reports that it was a 2 day meeting
- It is a 3 year study which is quite long
- There were small group discussions at the meetings
- A. Somers discussion topic was about how technology will change the profession of pharmacy
- O. Famuyide will be representing CAPSI National on the National Advisory Committee of the Pharmacy Human Resources Study
- A. Somers states this is good as she will be on CAPSI council for the next 3 years.
- He reports that there is a lot of money behind this study and lots of high profile members involved (e.g. Health Canada members)
- We will be receiving updates periodically

Item 6 Update on the NHPN

- NHPN was formed 2 years ago, and CAPSI is one of the founding organizations
- It is in interprofessional group, members are organizations, not individuals (therefore all CAPSI members are members of NHPN)
- It is composed national nursing, pharmacy, social work, residence, chiropractics, physiotherapy, occupational therapy student organizations
- Its mandate is to promote interprofessional communications
- The New Health Professionals Network (NHPN) continues to be a strong organization.
- Recent addition of Student Chiropractic Association makes it even more so
- NHPN will be holding their second annual Tommy Douglas Awards/ Members Summit in Ottawa on June 8th and 9th
- An award will be given to a group that demonstrates excellent interdisciplinary work at the Summit:
- Four categories for this award:
 - Mental Health
 - Home Care
 - General Disease Management
 - Primary Care
- A. Somers is chair for the Tommy Douglas Awards Committee, and his position will be passed onto M. Berg
- CAPSI members attending this summit: S. Baines, D. Boivin, A. Somers, M. Berg, J. Ramji

Item 7 APhA-ASP Relations

A. Somers

- our relations with the Americans are excellent
- M. Berg and A. Somers had a conference all with them in May and it is confirmed that we will be doing an article exchange with them three times a year (they will write 3 articles for the CAPSIL, and we will write 3 articles for their publication), as well as exchanging information on our respective educational programs
- They have a comprehensive education program and we hope to adapt at least one of them
- We will be sending them the Ratiopharm hand washing program
- On their website, they will be putting our picture and a description of who we are
- We will be reciprocating this on our website
- They are looking to send their president and president elect to PDW and we will look to sending ours to their national conference as well
- Another conference call will be held in June/July
- They have many novel ideas that we can learn from. A small sample:
 - Pharmacy Professionalism Tool Kit: used to increase the level of professionalism at their schools
 - Spaghetti Fundraiser: APhA-ASP have successfully solicited grocers to donate spaghetti and pasta sauce which is cooked by

- pharmacy faculty and students and ld for profit to help fund students' traveling expenses to their conferences
- "Pay-it-forward" Pie Fundraiser: students purchase pies to be sent to students and faculty at their school of pharmacy. The recipient of the pie will then be offered the choice of a pie in the face or to pay a fee to forward the pie to someone else who will have to face the same decision
- In terms of IPSF, the Americans have the same problems that we do (e.g. finding sites, recruiting students) so we hope to exchange ideas with them
- In general, our goal is to ensure the lines of communication are open

Item 8 Brief Note on the Canadian Pharmacists Journal

- A. Somers states that the CPJ is willing to give us room for submissions, it is up to us whether or not we would like to submit an article
- They also have a new editor
- Some council members had questions regarding the publicity of the Student Exchange Program, and whether they should just advertise in the CPJ, and what the deadlines are

Item 9 Mandatory Event Attendance at PDW M. Berg

- at the APhA- ASP conference, the student attendance at their annual elections and AGM comprised nearly 100% of the total number of students attending conference
- this was achieved by requiring all students seeking reimbursement for their expenses to attend
- Should we require mandatory attendance of students in order for them to get reimbursement as well? Should it both the elections and AGM? Or just one?
- M. Berg passes the gavel to O. Famuyide
- M. Berg states that he wants to increase participation in CAPSI National Elections
- M. Berg takes the gavel back

Immediate Concerns

- V. Masson states that this method will not work for students at Laval. The spirit of students coming to PDW is not for the council meetings. They like to have fun.
- There is also a language barrier. She doesn't see how they will benefit.
 - M. Berg confirms that students are not obligated to attend
- The amount reimbursed may vary from \$50 to \$500, there is concern that small amounts will not motivate students to attend the meeting
- Some feel the CAPSI AGM will be boring for the students and we need to make it more interesting. Otherwise the students will just sit there and sleep or talk. This will be no benefit to the students and reflect badly on us
- "paying students to watch us do our thing" seems wrong

- delegates will have a hard time understanding what we are talking about at the AGM, and it will take longer to run the meeting because we need to explain everything to them
- A. Somers addresses these concerns:
- PDW is not meant to be a party. It is fun, but that is not the point. We have an awesome education schedule and we need to promote this. It will be a lot of fun but we need to promote it as a professional conference where people will come to learn. Even if a student is hung over from the night before they can still make it to a meeting
- the language barrier: in the states, there are people who do not understand English but they still attend because they hope to learn something
 - F. St. James adds that language should not be a barrier as there will be translated slides
- small reimbursement: getting an amount as "small" as \$20 for one hour of sitting in a meeting is not a bad
 - O. Famuyide adds that for some students a significant amount of money is reimbursed e.g. \$200
- Make AGM more interesting: he likes this idea very much. He feels that if more people attend, the AGM will be more interesting. If less people attend, the AGM will be more boring
- "Paying students to watch us do our thing". Yes. That is what we are doing. We need to raise awareness of what CAPSI is about, what PDW has to offer, and take pride in what the executive council does
- the AGM is just a summary of what each member on council has been doing and delegates should not have much trouble understanding that

Discussion of Ideas:

- have the AGM at the same time as lunch so the students can have lunch while they are at the meeting
- hand out the alcohol/ party tickets until after the AGM
- have a debate at the AGM to make it more interesting
- not all 3 events (AGM/ Awards Ceremony/ Elections) should be mandatory, but pick one event
- charge students a higher registration fee and give them back the money if they come to the event (call it a deposit), ensure that students are aware they get their money back
 - A. Somers feels that any increase in registration fee will turn students away
- promote more interschool competition to make things interesting and more students will want to come to awards ceremony
- need to promote the elections more and what the positions are about
- provide breakfast or lunch or dinner only if delegates attend the mandatory event
- create stamp cards for delegates; in order to receive the ticket for the last dinner, they must get certain stamps on their card

- provide the tickets to the social events only if the delegates attend the mandatory event
- at this point A. Somers makes the following motion:

BIRT CAPSI National make attendance mandatory at either the AGM or awards banquet or the elections at PDW.

A. Somers/ M. Poole

Further discussion:

- council members feel that fundraising efforts at the local level should not be withheld from the students in order for them to attend the AGM or awards banquet or the elections, because they work very hard for this money
- G. Pauch also comments that they give students their cheques before they leave, so local fundraising money cannot be withheld
- A. Somers clarifies that if the elections is the mandatory event, the council members are the ones who vote, not the students. The senior representatives will get feedback from the delegates after the candidates have made their speeches
- J. Goulding disagrees with the reimbursement method because all schools give different amounts back and we cannot say that one delegate's attendance is worth more than others, however she supports raising the registration fee because everyone's registration fee is the same
- V. Masson is concerned that if everyone goes to the elections, the candidates will be stressed out because they cannot make a speech in front of 1000 people
- S. Baines states that having food at the AGM for the delegates will detract from the professionalism of the AGM because there will be a lot of background noise (e.g. plates clinking, chattering)

Item 3 Review of the iPharmacist Program

- CAPSI informs Apotex representatives that we prefer the iPharmacist program to be available to all years.
- If that is not possible, then just $2^{nd}/3^{rd}$ years
- we are able to provide them with our membership database, so that Apotex or CAPSI can track who has a coupon or who has used it

Campus Tour 2006

It was generally agreed that the online ordering process worked well last year and there were fewer issues around the 2005 Campus Tour. However, a number of concerns were listed: books did not arrive on time; reps did not know where the books were being sent; too many books and having to deal with returning them; confusion over offer of CPS book and eCPS; inconsistency with mailing dates for new CPS. Solutions were discussed for these problems including help for the CAPSI rep in making arrangements, getting the books to the universities earlier and providing information where they are to be delivered, providing courier tracking information. Pat Underwood said CPhA staff will stay longer at the universities to handle the book returns and also to be able to extend the hours when students may pick up their books.

Increasing Student Attendance at the CPhA Conference

CAPSI members who attended the APhA conference were impressed with the number of students and level of involvement of students at that conference. Although it was noted that US students' equivalent of PDW is held at the same time as the APhA conference, it was felt that there is still an opportunity to provide more student-oriented events at the CPhA conference. Le Devoir

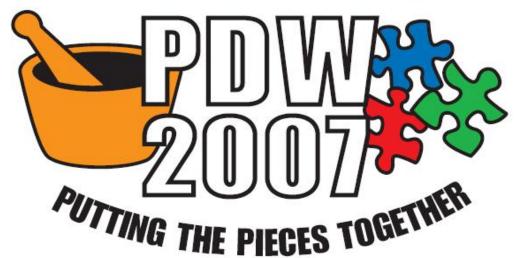

These are the preliminary numbers for the first wave of registration based on the maximum delegate capacity of 850, minus approximately 50 spots that need to be allocated for potential registration by pharmaceutical company representatives and members of the *PDW 2007 Planning Committee*. Should these 50 spots not be taken, they will also be redistributed between the nine faculties, or between those faculties that still have a delegate waiting list. However, if the interest and the sponsorship allow an increase in delegate registration, the opening and closing galas can accommodate up to 900 persons, therefore, we could also redistribute these numbers so that we account for 850 delegates, plus 50 spots for pharmaceutical representatives and *PDW 2007 Planning Committee* members.

Due to interest following PDW 2006 in Montreal, CAPSI National members have received copies of our promotional video. The remainder of the promotional material, as well as the registration forms, will be mailed out in mid-August to ensure that PDW 2007 promotion begins as soon as classes resume in September. Based on past years, registration will likely start Monday, September 25th 2006, and will run for three weeks, ending on Friday, October 13th 2006. The second wave of registration will begin a couple weeks after the first wave, and will end in mid-November.

Interest has been put forth for an online registration option. The *PDW 2007 Planning Committee* has looked into using **karelo.com**. This is a website company that handles conference and sporting tournament registration, and offers bilingual service. They will design our registration site based on what we need, and will provide daily reports to our committee of registration and payment information. They will allow us to link our respective page off of our PDW website for user friendly access.

Karelo will provide us with as many passwords as we need so that there's only one password per delegate. We will then distribute the appropriate number of passwords to each faculty's CAPSI representative who will distribute them accordingly at their school. Each password can only be used once, therefore, there is no risk of students sharing passwords and stealing spots from others. If a school doesn't use their allotted spaces by October 13th, they will be asked to return them to the *PDW 2007 Planning Committee* and will be redistributed to schools requesting extra space. In order to start the second wave of registration as soon as possible, all CAPSI representatives must mail back all unused passwords no later than Monday, October 16th 2006. The second wave of registration will start shortly after that, once the passwords have be collected and sent out to faculties that have requested additional spots, likely the last week of October or first week of November. The second wave will also run for two to three weeks until mid-November; a third wave will only be done if spots still remain.

When working with Karelo, we can set up our registration page so that there are mandatory fields to ensure we collect all the information we need. In other words, a delegate can not submit their registration and payment until all mandatory fields are complete. Since e-mail addresses can be a mandatory field, this can allow the PDW 2007 Publicity and Registration to be fully responsible for obtaining flight arrivals/departures directly from the delegates themselves, instead of CAPSI representatives. However, the program only accepts credit card payment, so it's important to inform all students that they need access to a credit card to register.

Costs:

Set-up fee - \$199.00

Monthly fee - \$15.00/month for 5 months (max) = \$75.00

Transaction fee – 5% of each transaction that's less than \$200.00

Therefore, 5% of \$140 registration fee for 850 delegates =

\$5950.00

Password set-up fee - \$400.00

TOTAL = \$6824.00

This additional convenience works out to cost an extra \$8/delegate.

Speaker Bios

Mr. Stephen Lewis - Motivational Speaker

Stephen Lewis is the UN Secretary-General's Special Envoy for HIV/AIDS in Africa, a post he's held since June 2001. He is also a Commissioner for the World Health Organization's Commission on the Social Determinants of Health, and a Senior Advisor to the Mailman School of Public Health at Columbia University in New York. Mr. Lewis is also a director of the Stephen Lewis Foundation, which is dedicated to easing the pain of HIV/AIDS in Africa. Mr. Lewis' work with the UN has shaped the past two decades of his career. From 1995 to 1999, Mr. Lewis was Deputy Executive Director of UNICEF at the organization's global headquarters in New York. In 1997, in addition to his work at UNICEF, Mr. Lewis was appointed by the Organization of African Unity to a Panel of Eminent Personalities to Investigate the Genocide in Rwanda. The 'Rwanda Report' was issued in June of 2000. In 1993, Mr. Lewis became coordinator for the international study -- known as the Graça Machel study -- on the "Consequences of Armed Conflict on Children". The report was tabled in the United Nations in 1995. From 1984 through 1988, Stephen Lewis was Canadian Ambassador to the United Nations. In this capacity, he chaired the Committee that drafted the Five-Year UN Programme on African Economic Recovery. He also chaired the first International Conference on Climate Change, which drew up the first comprehensive policy on global warming. Mr. Lewis holds 22 honorary degrees from Canadian universities and is an honorary fellow of the Royal College of Physicians and Surgeons of Canada. In May 2003, in recognition of outstanding contributions to public health, Columbia University's Mailman School of Public Health honoured Mr. Lewis with the Dean's Distinguished Service Award. Mr. Lewis was appointed a Companion of the Order of Canada, Canada's highest honour for lifetime achievement, in 2003. The same year, Maclean's magazine honoured Mr. Lewis as their inaugural "Canadian of the Year." In March 2004, Mr. Lewis was honoured by the United Nations Association in Canada with the Pearson Peace Medal, which celebrates outstanding achievements in the field of international service and understanding. In April 2005, TIME magazine listed Stephen Lewis as one of the '100 most influential people in the world'. The same year, the International Council of Nurses awarded Mr. Lewis their prestigious Health and Human Rights Award, which is awarded quadrennially for outstanding contributions to international health and human rights. Stephen Lewis' book, Race Against Time was released in October 2005, and is published by House of Anansi Press (www.anansi.ca).

Dr. Myrella Roy - Keynote Speaker

Dr. Myrella Roy is a clinical pharmacist, manager, teacher and consultant. For much of her career, she has worked at the Ottawa Hospital where she managed the pharmacists and the clinical pharmacy services at the General and Riverside Campuses, coordinated the hospital pharmacy residency program and maintained an active practice first in critical care, then in neurosciences and

finally in a heart failure clinic. Dr. Roy has held faculty positions at the University of Montreal, Laval University in Quebec City and Claude Bernard University in Lyon, France. In 1999-2000, she served in Albania as a volunteer with Pharmacists without Borders. Since April 2003, Dr. Roy is the Executive Director of the Canadian Society of Hospital Pharmacists. She was the founding President of the Canadian College of Clinical Pharmacy and has served in various capacities with the Canadian Society of Hospital Pharmacists and the American College of Clinical Pharmacy. Dr. Roy holds a B.Sc. in Pharmacy and a diploma in hospital pharmacy from the University of Montreal and a Pharm.D. degree from the University of Cincinnati.

Dr. Rob Ariano - General Speaker and Panel Discussion Mediator

Dr. Rob Ariano earned his bachelors degree in pharmacy from the University of Manitoba in 1980; completed a residency from the Ottawa General Hospital in 1983; and obtained his doctorate in pharmacy degree from the University of Minnesota in 1988. Since 1988 he has acted as a clinical pharmacist to the intensive care units at the St. Boniface General Hospital, and is also a clinical associate professor with the Faculties of Pharmacy, and Medicine at the University of Manitoba. His research interests are in drug metabolism and pharmacologic responses in the critically ill patient.

Professor Robert Chernomas - General Speaker and Panel Member

Professor Robert Chernomas has a Ph.D in economics and has been a member of the Department of Economics at the University of Manitoba since 1980, except for the two years he spent at the Johns Hopkins University School of Public Health as a visiting professor. He has published in both the academic and popular literature with respect to macroeconomics, the history of economic thought, health care economics, post-secondary education and in the area of the socio-economic determinants of health. He has lectured in Canada, the US, China, Africa and Europe. He has taught health economics at the undergraduate and graduate level at a number of North American Universities and is currently on the editorial board of the International Journal of Health Services as well as serving as a referee for Social Science and Medicine and a number of other peer review journals.

Dean David Collins - Panel Member

Dr. David Collins M.P.S., M.S. (Minnesota), PhD (Minnesota) was initially appointed Dean of the Faculty of Pharmacy at the University of Manitoba in September 1999, and subsequently reappointed for a second term in 2004. Dr. Collins received his Pharmacy education in his native New Zealand and after ten years as a practitioner, principally in hospital practice, returned to graduate studies. He earned his Doctor of Philosophy degree at the University of Minnesota, working with Theodor Litman, School of Public Health and Faculty of Sociology. Prior to taking up his current appointment he held academic and clinical appointments at the University of Otago and the Otago Regional Hospital

Board, NZ; and at the University of Queensland and the Princess Alexandra Hospital in Queensland, Australia. He was recruited to his current position from Australia, where he served as Head of the University of Queensland's School of Pharmacy. His research interests are in the area of outcomes evaluation, specifically addressing the impact of pharmacy services. Dr. Collins has an extensive background in pharmacy both as a practitioner and educator. Prior to entering the academy he served as Director of Pharmacy at Wellington Hospital, NZ. He also served as Vice President of the Wellington Branch, Pharmaceutical Society of New Zealand (1984). Subsequent to moving to Australia was a ministerial appointment to The Pharmacy Registration Board of Queensland (1993-1997), and a member of the Pharmaceutical Health and the Rational use of Medicines (PHARM) Technical and Advisory Group (TAG) (1993-2000). He also served on the Academic Advisory Board of the Australian College of Pharmacy Practice (1992-1996). Dr. Collins has served as a member of the Manitoba Pharmaceutical Association Council since his appointment in 1999.

Mr. Kevin Hall - Panel Member

Kevin Hall obtained his B. Sc. Pharm. From Dalhousie University in 1976 and his Pharm. D. from the State University of New York at Buffalo in 1978. He then moved to Winnipeg where he joined the staff of the Health Sciences Centre as a critical care clinical pharmacist (1978-1986), and later held positions as Assistant Director of Pharmacy (1986-1991) and Director of Pharmacy (1991 to 1998). In 1998 he became the Regional Director of Pharmacy for the Winnipeg Regional Health Authority. He has been active in a number of pharmacy organizations and has served as President of both the Canadian Society of Hospital Pharmacists and the Canadian Pharmacists Association. Kevin is presently serving as a member of the National Advisory Committee for the development of the Canadian Medication Incident Reporting System (CMIRPS), and co-chairs the Steering Committee for a national study of pharmacy manpower issues. He served for over 10 years as a member of the Editorial Advisory Board, and is currently the Managing Editor, for the Hospital Pharmacy in Canada Survey that collects and publishes comprehensive data on hospital pharmacy practice in Canada (www.lillyhospitalsurvey.ca).

Myriah Lesko - Breakout Speaker

Myriah Lesko graduated from the University of Manitoba Faculty of Pharmacy in May 2003, after having previously completed a Bachelor of Science degree at the same institution. Since that time, Myriah has practiced community pharmacy and eventually made the permanent move overseas to work for the International Pharmaceutical Federation in The Hague, The Netherlands. Throughout her time in Pharmacy School Myriah began participating in the International Pharmaceutical Students' Federation (IPSF) student exchanges abroad, which brought her to such places as Spain, Malta, Hungary, Singapore, and The Netherlands to name but a few. As time progressed, Myriah became more and more involved with IPSF and eventually found she serving on the IPSF Executive Committee in the 2004-2005 year, the initial reason for the move overseas to The

Hague. This eventually led to a full time position with the International Pharmaceutical Federation. Since then, both student and professional involvement has seen Myriah travel to over 25 countries and 45 cities.

Professor Michael Namaka - Breakout Speaker

At present Michael Namaka is an Assistant professor at the Faculty of Pharmacy at the University of Manitoba. In this capacity Michael functions as a neuroscientist and a clinical pharmacist practitioner. This dual capacity has allowed Michael to bridge basic science research to clinical practice. Michael has his own independent neuroscience research laboratory focused on the underlying pathology of multiple sclerosis. In his laboratory, Michael supervises a Post-doctoral Fellow, MD-Ph D and Master's students. In addition, Michael is the only clinical pharmacist practitioner in Canada. In this novel role, Michael has been trained and certified to function as an extension of the neurologist by independently assessing patients, prescribing drugs, performing basic neurological exams as well as active involvement in the symptomatic management of multiple sclerosis patients on follow-up visits. This new approach to pharmaceutical care and his active involvement within an interdisciplinary team of health care professionals has been cited at the Canadian (CSHP website: May 2002) and International Level (International Multiple Sclerosis Society website in New York: June 2002). Since his appointment at the Faculty 2 years ago, Michael holds numerous research grants and has performed an excess of 30 invited presentations. Michael Namaka has also recently been awarded the prestigious international: "Commitment to Care Award for his innovative MS research and clinical neurology practice. In addition, Michael Namaka is the appointed Research Chair across Canada for AFPC.

Dick Nguyen - General Speaker

Dick Nguyen graduated from the University of British Columbia in June 2005. After spending his summer traveling South America, he is currently working in a community pharmacy in Kamloops BC. At present, he is training to be a Diabetes Educator as well as trying to develop an INR monitoring clinic at his pharmacy. In the future, he hopes to spend the majority of his time providing cognitive services in the community. Outside of school, Dick thoroughly enjoys traveling, having already been on five of the seven continents. One of his highlights was volunteering for the Neema Project in Tanzania and having the opportunity to explore East Africa.

Mike Sullivan – Breakout Speaker

Mike Sullivan co-founded Cubic Health Inc., a Toronto based drug plan management and clinical integration company in December 2003. Cubic Health is involved in drug plan analyses, management and design for medium to large size private and public plan sponsors. The company also provides stakeholders in the Canadian healthcare industry with key information related to the therapeutic classification and utilization of drug products in Canada. In his role as

President, Mike oversees the day-to-day operations of Cubic Health, and acts as a liaison between the consulting, clinical, and information technology divisions of the company. He is involved in Cubic Health's strategic planning and expansion into new markets. Previously, Mike was an independent consultant within the drug plan management and benefits consulting industries for a number of national clients. He also has experience is sales, marketing and professional program development within the pharmaceutical industry. Mike maintains an active license with the Ontario College of Pharmacists by practicing an average of 300 hours per year in community pharmacy practice. He is a graduate of the College of Pharmacy at the University of Saskatchewan, and received his Master of Business Administration (MBA) degree with a specialization in Finance from the Schulich School of Business at York University. He is a Past President of CAPSI, having served on the Executive Council from 1998 until his graduation in the spring of 2000.

Shirley Treacy - Breakout Speaker

Shirley Treacy is a forensic toxicologist and civilian member of the Royal Canadian Mounted Police, and has been stationed at the Forensic Laboratory in Winnipeg, Manitoba for approximately 20 years. She graduated with a Bachelor of Science and a Master of Science degree in Pharmacy from the University of Saskatchewan and now teaches a course in Analytical Forensic Toxicology through the College of Pharmacy, University of Manitoba. Her present duties include lecturing police investigators, pharmacy students and the general public on areas related to forensic toxicology and drug/alcohol impairment; acting as a resource person for the Courts regarding analysis of biological exhibits, and the pharmacological effects of drugs on humans; and examines body fluids and tissues as well as unknown powders/liquids/tablets for the presence of drugs and poisons.

Dr. George Zhanel - Breakout Speaker

Dr. Zhanel is a microbiologist and pharmacologist who received his Ph.D. in the Department of Medical Microbiology/Infectious Diseases at the Faculty of Medicine, University of Manitoba and a Doctor of Clinical Pharmacy at the University of Minnesota. He is presently Professor in the Department of Medical Microbiology/Infectious Diseases, Faculty of Medicine and Coordinator of Antibiotic Resistance in the Departments of Medicine and Microbiology, Health Sciences Centre.

Dr. Zhanel has published over 500 papers and abstracts in the area of antibiotic resistance. He has presented over 600 lectures as an invited speaker at international, national, and local meetings speaking on the topic of antibiotic resistance in Canada, United States, Central America, Western and Eastern Europe including Russia, Australia, Southern and Northern Africa, the Middle East and Far East. Dr. Zhanel's antibiotic resistance interests include understanding the prevalence and epidemiology of antibiotic resistant infections, describing the clinical relevance of resistant infections, identifying and developing

molecular diagnostic methods to rapidly diagnose resistant infections, investigating the molecular mechanisms of resistance and studying pharmacodynamic modelling and Monte Carlo analyses to provide optimal treatment of antibiotic resistant infections. Assessing the medical and economic outcomes of antibiotic resistant infections as well as studying the relationships between antibiotic use and the development of antibiotic resistant infections is a priority.

Also:

Since January, there has been some restructuring of our committee, and we have added 8 new positions. We hold bi-weekly meetings during the school year, and this summer we are keeping updated via e-mail. We are well on our way with the planning of PDW 2008 and the following will highlight our progress thus far.

<u>Theme - Empowering our Patients</u>

Our theme is 'Empowering our Patients'. The theme focuses on how to teach patients to take responsibility for the maintenance of their health, and how to take an active role in their medication therapy. As first line healthcare professionals, we can influence and educate our patients to be self aware about their current state of health, through repeated interactions in hospital and community. This theme will be explored through various avenues such as, speakers discussing pharmacist interventions, chronic conditions of the present and future, as well as workshops to enhance skills when working with diverse populations.

Pharmacist interventions have been proven to reduce the long term costs of a patient's care. Through educating the patient about their disease and its management, the pharmacist can aid in reducing the overall morbidity and mortality of the patient. Prospective keynote speaker Dr. Ross Tsuyuki has had great success studying the interventions of pharmacists with cardiovascular patients, and the conference has the pleasure of opening with him.

Understanding the chronic conditions that affect Canadians and being aware of how to manage them is the pharmacist's responsibility. Chronic conditions are often treated outside the hospital, on a long-term basis; therefore, a greater understanding of these conditions is essential in order to provide through education to the patient. This conference is going to have specialists from a wide array of backgrounds discuss such issues as psychiatric illness, diabetes, warfarin management, AIDS/HIV and womens health.

Canada is a country that accepts people of diverse backgrounds. One of the essential requirements of educating patients is communicating with them. Therefore, it is truly important for pharmacists to be culturally sensitive and understanding. We must also be creative, in order to get the required information to our patients. Dr. Earle Waugh will be discussing how to remove cultural barriers, and Dr. Matt Rose will be speaking on the major issues that affect the inner city.

With our aging population, the importance of patients taking responsibility for their own health is exponential. As healthcare professionals, it is our obligation to educate patients on how they can be actively involved in their own therapy. Understanding what they are taking, why they are taking it, and how they can improve their own quality of life reduces the burden on the healthcare system, which ultimately makes it more sustainable.
