University of British Columbia

- F. Huang/A. Chernenkoff ipharmacist demo session by Apotex - students felt that it was informative but would have liked to know more on how to apply the ipharmacist during school.
- Competitions went really well some difficulties with compounding. _
- Fundraising bake sale, CAPSI candygrams, and CAPSI Bingo and Jeopardy.
- Had another symposium and another clubbing event for fundraising.
- Subsidy unable to give additional subsidy with 100 delegates, but are still giving them 3 options to attend.

University of Alberta

S. Dyjur/E. Tu

- E. Tu organizes the seminars diabetes, blueprint for pharmacy, pharmafacts (mini-prep for PDW). Leadership Novopharm dinner will be held in February.
- Subsidiary don't fundraise for PDW, so the students' names will go into a draw for an ipod with the money left over from CAPSI Awareness Week.
- Valentine's Day Date auction
- CAPSI Agendas some complaints, but will discuss later with Jen.

University of Saskatchewan

K. Gudmundson/J. Swidrovich

- Compounding competition U of S has only 6 stations so had to do 2 rounds.
- Two professors have offered to work with students on competitions to ensure that the content of the compounding competitions are within the scope of what the students are being taught in the schools.
- First ever symposium and survey online and it went really well.
- Jaris got educational subsidies organized really well by making ballots for the students.
- Specialist came in locally to give a talk with Wyeth for a session. Within local scope in lieu of financial speaker who comes in every other year, so that there would be something offered every year.
- Fundraising for local CAPSI Bachelor/Bachelorette auction, etc. _
- Started Finance Officer position with the CAPSI local council which was a really good idea.

University of Manitoba

- Have done a lot of fundraising for PDW with \$250 per student. -
- Held socials for fundraising which raised quite a lot in December and last Friday in January. Cover of \$7 and students can come for drinks and dancing.
- Other events organized Handwashing Campaign, 30 hour famine, organizing PAW. _

- Is any money coming from alcohol sales? No, just ticket sales, 50/50 and silent auctions. _
- CAPSI's stance is that revenue from events does not come from alcohol.

University of Toronto

- M. Irvine/R. Knott
- Fundraising Cupcake delivered to students for birthdays for \$1.
- Charity week Made \$3000 from professor auction. _
- Education subsidy 4 of 18 sessions including 1 of 3 mandatory CAPSI events. _
- Symposia: good turnout for a talk with U of T professor. Ballot at end of symposium with paper _ and a reception was held afterwards.

M. Green/C. Leong

Université de Montréal

M. Naim/P. Orfali

- More students attended the competitions than last year. There was more competition between _ students for the fewer spots available at U of Montreal.
- Guy-Genest award- Much better competition between students.
- Education subsidy Since U of Montreal has fewer students, students were asked to attend 2-3 events and P. Orfali and M. Najm will take attendance.
- Finding it difficult to implement CAPSI into PharmD program. The PharmD students were only at the school once a week, so it's hard to get in touch with students.
- Will speak with the dean and faculty members and maybe look at making CAPSI membership mandatory and students can choose not to pay for it if they don't want to join.
- O. Famuyide mentions that this will be a trend with PharmD program. CAPSI will need to address in the future with Membership committee. Mandatory membership is a good idea, but also need to advertise CAPSI.

Université Laval

- P. Boivin/A. Giroux
- 60 students from Quebec attending PDW 2008. -
- Patient Interview Competition only 3 students participated this year.
- A. Giroux organized the conference with CSHP which was really successful. Mostly for first years and got 60 students to attend to hear four people talk about jobs with good feedback.
- The English software was removed from the ipharmacist for the French students and only the Vigilance program was added. The students had called the company and managed to get this fixed. The Vigilance program was then added to the English program.

Dalhousie University

M. Poole/J. Rankin

- Competitions were well received there were at least six students for each competition and three teams for compounding.
- Five students participated in the literary challenge.
- Students at Dalhousie don't really do fundraising for PDW with CAPSI

Memorial University of Newfoundland

VP Education

Agenda

- CAPSI Agenda went with same advertising company as last year and had a net revenue of \$3000.
- Last year, 2400 agendas were printed and wasn't enough to supply all schools. Also, next year there will also be school of Waterloo. Different binding options. Will have agenda review committee
- Ad submission deadline was in April and this didn't give a lot of time for printing delays. Hopefully, this year the CAPSIL would be printed in mid June.
- Do not call list was made which includes 28 companies that only CAPSI can contact for advertising.

Corporate Sponsors

- CAPSI Club Jolanta increased up to 7 last year. Hoping to get up to 10 this year.
- PR package will be going out to companies to about the benefits of CAPSI Club and advertisement in the agenda and make it clear that it is a 2 for 1 package.
- 2 issues of CAPSIL Gold : Increase benefits ½ page space and ¼ space in CAPSIL.
- Honorary Life Members were sent Christmas cards.
- Astrazeneca were supposed to meet at CPhA, but didn't show up. Continue support of VTC, but not the patient interview competition. Haven't heard back from them in awhile and should not need to beg for sponsorship. May need to look for other support for VTC.
- M. Berg suggests should try to set up a sponsorship contract maybe for a extended period i.e. 3-5 years to prevent disconnect each year.
- Student Literary Challenge Support Approached CPJ and they were willing to give \$1000 for national prize. Pharmacy Practice unable to support at this time.
- CAPSIL R. DeFazio and J. Wiebe will be meeting re: formal structure of advertising. Meeting with CPJ for some guidance.

University of Waterloo

- Ken Potvin is really excited to start CAPSI chapter. They have hired a coop student dedicated to start up the CAPSI chapter.
- Presentation by M. Poole and M. Irvine will be at U of Waterloo on Jan 29.
- Need to gather resources from different schools. It is a challenge to have a format to start up chapter since each school is so variable.
- ipharmacist demo session need feedback from all schools to give to Linda. Overall feedback has been good.
- M. Berg mentions that the president of CNSA attending at PDW used to used the same advertising company and has switched to another company and doubling profits.
- O. Famuyide says that the Membership Database could be used to correlate an estimate for numbers for the CAPSI agendas.

VP Interprofessional Affairs

- CAPSI support for any help with starting up the Canadian Interprofessional Students Network.
- The objective of CISN is for professional associations to become members of CISN to disseminate interprofessional initiative/opportunities.

J. Reid

M. Berg asks what initiatives have been disseminated by CISN? CISN started in June 2007 and information was sent out to CAPSI representatives to disseminate in the fall. It has been difficult for CSN to start up as communication has been choppy.

O. Famuyide explains that CISN is related more to facilitation of communication which is provided to representatives from different interprofessional associations. NHHSA is related to promoting interprofessionalism and education. NHHSA is heavily supported by Health Canada and are able to facilitate videoconferences, etc.

CAPSIL Editor

- Due to bi-elections for CAPSIL Editor, will only have two issues this year.
- Haven't received the laptop from the old editor, but had wanted issue printed here at PDW at Staples.
- The deadline for submissions for the next CAPSIL will be March 3.
- M. Irvine asks about the RX&D program deadline that was usually in January.
- O. Famuyide says that the industrial residency program is interested in working with CAPSI perhaps having ads in CAPSILs. Maybe the program might have pushed back the deadline to incorporate the ad in the spring CAPSIL issue.

IPSF Liaison

- IPSF and CAPSI are on good terms.
- IPSF manual made for local representative to get a better picture of what they are doing.
- Thanks to all senior and junior representatives and local IPSF from each school.
- Yahoo group was started for IPSF and updated every 2 days.
- IPSF meeting will be held during PDW which all IPSF representatives are attending. _
- Will recognize some outstanding examples of IPSF promotion at various schools at AGM.
 - AIDS awareness campaign in November. H. Doyle from Dalhousie did a fantastic job and organized a fundraiser for 'Little Travelers' and raised \$250. IPSF rep from U of T had AIDs information every day, had interview with doctor from local hospital and wrote article. At UBC, had an International Pharmacy Week with 1 hour presentations everyday with PSF, volunteering abroad.
- PSF reps had sent out a video of the second tsunami, but if any schools want to show again, please contact S. Leung.
- WHO internships available in summer and can apply for this in the second term.
- Moving on survey is done in various countries involved with IPSF. Moving on 3 Survey talking about migration to 4th year students.

Congress in Taiwan

- Attended workshops there.
- Three Canadian delegates participated in the patient interview competition and two Canadians won in beginner and advanced level.
- Next one in Romania and a lot of students are interested. In November, there was an interdisciplinary conference in Spain.
- F. Huang wants to mention that the two students who won the PIC were from UBC. S. Leung did a good job to promote IPSF at UBC.
- The student opportunities are only exclusive to the two French schools right now.
- M. Najm mentions that the second tsunami presentation at Montreal was great and students who already saw it came back to see it again. Great idea to show to students to give students idea about what PSF is about.

Student Exchange Officer

SEO program

- Deadline was Dec. 28. Last year had 10 applicants, so this year had 24 applicants.
- 3 students to be sent this year.
- Accepting a lot more international students so able to send 11-14 students on exchange next year.
- Research position tons of interest on this all over the world.

Liability insurance issues

- Stores worried about international students getting hurt so nothing is in place right now. O. Famuyide and C. Cho-Kee are working with lawyers on this issue.
- Lawyers feel that CAPSI as an organization would not be liable. However employers are wondering if students get injured on site, can students sue them?

CPJ

- CPJ did a phone interview with C. Cho-Kee on SEO program and on great experiences from stores.

Finance Officer

L. Dagg

- Financially, things are better than at CPhA.

CAPSIL

- Spring CAPSIL issue wasn't distributed and picked up at University of Laval at all. National had to pay for these expenses. Reminder to local council that national should not have to incur these kinds of expenses.
- CAPSI National will pay for 10% of school's population of CAPSIL costs. CAPSIL was printed at Staples and wasn't picked up.

PDW Expenses

- Fiscal year ends March 31st and council members are not sending in expenses before this deadline. Takes out a chunk of budget from last year's overlap.
- Please get these expenses sent in immediately and will be setting deadlines for how soon expenses should come in.

Taxes

- November taxes not filed from Mar. 31st. Accountant's dad passed away in fall and things got farther behind and now accountant is on holidays.
- Government implemented an April 1st deadline that if taxes not filed within 6 months of this there will be a charge of \$2500.

CAPSI Agenda

- Agenda brought in \$5400 profit. CAPSI Club brought in \$14000.

Financial Situation

- \$50 000 in bank account at end of year. Right now in good shape because no one submitted expenses for PDW.
- M. Najm suggests that CAPSIL could save a lot of money by having a single CAPSI version with both English and French. Some students from Quebec could even read the English part too.

- Hired our Webmaster P. Lam to help input the CAPSI Membership information into the Membership Database for all the schools except for U of T. The reps had difficulty with U of T not wanting to disclose students' information. We are still trying to figure that out.
- Updating our Minutes with our Lawyers and Accountants since we have not been sending them our Minutes from 2003. So each year at the end of their term. The executive secretary must send out 2 Minute books - one to Lawyers and one to keep for our CAPSI records.
- Also, working on registering for a new mailbox for CAPSI in Toronto.

President-Elect

Moving Forward meeting- update later on this afternoon.

Past President

- Mainly advisory role.
- Chair CAPSI National Ethics Committee London Drugs advertising to help fundraise for PDW for students. Conclusion – this year acceptable to wear lab coat advertising. Sponsorship of individual students needs to be assessed on case by case basis - due to possible conflict with CAPSI sponsors at PDW.

President

Moving Forward survey

- Coordinated by Dr. Neil MacKinnon. 30% of students responded. 1300 respondents vs. 2600 respondents in US and they have 10 times number of schools in Canada.
- Results released 2 days ago work with Neil and Jonathan to come up with putting something through the spring issue and trends from survey and how this will impact future in pharmacy. Competitions

- OTC and PIC cancelled. Wyeth sponsored OTC. After assessing and exploring all possible avenues, decided that didn't have the time in present situation with VP Education.
- Need to establish deadlines and timelines for competition cases.
- Schools provide funding for students to come to compete in competition.
- Meeting to talk to local winners for OTC and PIC tomorrow at 9am.
- Reimbursements for travel subsidy still given to students. Funds for potential winners won't be given.
- J. Goulding says that the notice regarding references came too late.
- O. Famuyide says that the references available at the Compounding Competitions are the CPS and Remingtons and this is all they need. Anything on top of that is extra. If students feel like they need additional references, can use.

Directive: Defer to Competition Review Committee to decide what references are to be made available for each competition.

Competition Review Committee already made up a list of references, but will keep working on this.

BIRT CAPSI National discusses Agenda item 15. M. Berg/J. Mailman Motion Passed

Item 6 VP Bilingualism Position on the CAPSI Executive Council P. Boivin/M. Najm

This discussion is intended to elucidate comments and discussion on the potential role for a Vice President of Bilingualism. As a national association, it is felt that the Association needs to make a greater commitment to providing services in both official languages. Some of our national student health professional organizations also employ a similar role and this discussion is intended to gather council's thoughts on this matter.

- P. Boivin has idea to bring on a CAPSI executive position for bilingual position to benefit council on translation to make it easier to disseminate info to students in Quebec who only speak French.
- Ô. Famuyide CNSA currently has similar type of role in their organization, won't mimic exact role of CNSA. Discussion to gather feedback from council if we should explore this option.
- M. Najm mentions that CAPSI actually sponsors competitions at Montreal and Quebec conference. Everything for translation but stuff on website, or some small stuff on CAPSIL. Good idea with all the changes around the Quebec schools. The rep in this position would be involved in translation for website and CAPSIL.
- F. Huang asks if the Quebec school have tried this position at the local level? No, they haven't tried the new position yet.
- M. Berg says that at CPhA, this position was intended to increase engagement of the French students on National level. Primary concern, what are the specific duties does this position have? How you would see the position's scope of responsibilities?
- P. Boivin says it is difficult to come up with ideas right now. What role do u want this person to serve? To be on the executive council is really hard for French students. They don't think there is enough representation on the CAPSI national.
- J. Goulding It seems like you are making another Quebec position. It is not like no matter what school you are coming from, you should be able to apply.

BIRT that CAPSI National creates a VP Bilingualism position on CAPSI National of which the roles and responsibilities will be determined by an ad hoc committee. M. Berg/F. Huang Discussion

- If students from Quebec apply for positions on executive it is difficult, but anyone who is French speaking should be able to have a shot at this position. Not just focused on translation, more of a French liaison position on the council. Someone who could go with VP Communications to help with translation or website, or to aid in attendance of CAPSI Executive to the conference between Montreal and Quebec.
- M. Berg inquires whether this is the best way to increase engagement from francophone pharmacy students? A lot of costs with creating a new position.
- M. Irvine thinks this is a good idea and in Canada this should have a Coordinating translation, making sure that things would be available in French and English. Not a point of the position to have more room for Quebec students.
- J. Rankin says that this is a great opportunity for French incorporated into CAPSI initiatives. Don't understand students from Quebec not feeling like they can run.
- M. Irvine says that the bilingual students may not feel comfortable running for certain executive positions. i.e. CAPSI Editor, VP Communications due to the grammar, written and verbal skills needed. Would not be as good as the English speaking students.
- J. Mailman asks are we trying to engage all of French speaking students or just Quebec students? Concerned regarding costs.
- J. Goulding says that until we have the roles, we can't evaluate the cost vs. benefit. If you could put together the roles of this position then come back to council with it, we can discuss further.

Item 2 Update on Student Working Group

J. Poston

- Was thinking about substituting the CPS with e-CPS and making a joint membership with CAPSI, but it didn't get a lot of support.
- Student working group idea with the goal to shift the focus from campus tours to CPhA having a role as helping to improve professionalism i.e. with government workshops and events with Barry Power (continuing education such as the pandemic plan, something that is not in the curriculum).
- Thinking about a universal membership and every student becomes a member at no charge, but there will be no free CPS anymore and would look at offering to students at a discounted price.
- CPhA would like to work closely with CAPSI on individual faculty level to see how programs are developed.
- K. DeGirolamo working on proposal for this for 2008-09 or 2009-10.
- Fairly significant discussion at March board meeting. Fine tuning then goes to board meeting in May.

Item 3 Integrate Graduating Students into CPhA Memberships J. Poston

- CPhA Membership is relatively low for graduating students but it is usually good for 1, 2, 3 year students.
- Wants to develop program for more CPhA presence with graduating students.
- Thinking about giving a graduation gift to graduating students (perhaps as a year of free membership post-graduation and this would give some support for first year of being a licensed pharmacist). Would like CPhA
- Going to see a drop off as people are faced with reality of paying the fee. See the need to maintain involvement and need more young pharmacists in membership base.
- Important to retain larger numbers as an association. There is a lot of recycling of board members and presidents. Without younger pharmacists, the associations are not representative of the points of view of all pharmacists.
- Interest of politicians will be attained if have younger pharmacists too vs. old business owner.

T. Nguyen

- Manitoba has an easier time to get graduating pharmacy students. They had 2 or 3 outstanding female pharmacy leaders; they have very definite goals of how they want to practice.
- O. Famuyide says that a lot of it starts with individuals; CAPSI is trying to engage students that you do have a choice that you can make individual decisions.
- M. Berg thinks that not all students are fully aware of what CPhA is about. Heard about it in first year, but that was the last that was heard of CPhA. Need to engage fourth years to tell them what CPhA is involved in at this time and what you can do with it. Government workshop is one step.
- CPhA could get all students' university email addresses and communicate through that. If there was funding, a fourth year conference. We need some evaluation of what the preparation is like for graduating students moving into practice.
- Centennial award winners engages very narrow spectrum of involved students.
- Often graduating students focus on graduating, PEBCs. Maybe engaging students in fourth year is a little too late, and repetition is important, maybe try to engage students in third year. Will look at which year to focus on CPhA promotion.
- CPhA could offer subsidies to students to attend the FIP conference (Father association of IPSF).
- Advertise the money (\$4000) given to CAPSI which is often used to send students to PDW.

Item 4 E-Therapeutics Feedback

- P. Underwood extended trial of e-therapeutics. Poll of how receptive students were. Tracking the number of hits.
- Eight of the schools had it at their library. Montreal and Laval don't get any exposure to the program at all. e-therapeutics is in English only and the e-cps is not available in French.
- French students could still use this resource in English. These students still use English textbooks already.

Item 5 Student Exchange Program

C. Cho-Kee

- Increased from 10 to 24 students and promoted very well. Finding the host sites was going very well.
- Thanks for CPJ article to promote program, and interviewed pharmacists that had taken students. First national exposure the program has had so far.

DISCUSSION #1:

We are all aware of the financial difficulties CAPSI National suffered from last fiscal year. In response to that, and also because it was due time, the following motion was passed at the July 2007 Budget Teleconference:

"BIRT CAPSI National increase CAPSI membership fees from \$9 to \$10 (F.Huang/K. Gudmundson)."

At this time, only the University of Toronto expressed concern with regards to the increase in fees since their CAPSI fees are tied to tuition. Since then, Leslie has received a request from Dalhousie (who also has fees incorporated with tuition) to consider a "grandfather" clause for those universities having mandatory CAPSI fees submitted with tuition. This discussion was brought to the Finance Committee and the following motion has been put forth to deal with the situation:

Discussion:

- With future expenses going to Newfoundland for PDW, it will be more expensive to travel and it is important to implement fee increase now.
- We established this fee membership increase last year. Dal and U of T aren't able to implement changes as fast, but will work to have this fee increase implemented.
- At Dalhousie, CAPSI local is going to take a hit. Our student society pays \$12 for CAPSI local and national.
- If there is a fee increase in the future, there needs to be one year to allow for changes.

BIRT CAPSI National provide all nine Canadian schools of Pharmacy with a grandfather clause of up to one (1) year to implement the CAPSI student membership fee increase, approved on July 8, 2007.

- Can work with Neil and his team to make a 1 page summary. Also, will be available on website. It is important to provide feedback to students.
