7. Waterloo Students Running for President-Elect

Background: It has been brought to the Presidents' attention that with our recent election procedure changes, Waterloo students may now be at a disadvantage for applying for the position of President-Elect. According to the OM, the President-Elect position is "a three-year commitment (sequential one-year terms as President-Elect, President, and Past-President) for which at least two of the three years must be served as an undergraduate student." Given that the application deadline for our re-vamped election process is now in the December leading up to PDW (to allow for video recording, review of applicant materials, and posting on the MoP), first year Waterloo CAPSI members will be unable to apply for any positions on council unless a unfilled position proceeds to a by-election (see chart below). This discrepancy from other universities is particularly pertinent for the President-Elect position, as it must be applied for within a student's first two years of a pharmacy program, as the OM is currently written.

Our elections procedure needs to be reflective of our value of unity and inclusive/fair to the members at all 10 pharmacy schools. I would like to suggest that we discuss allowing 3rd year Waterloo students to apply for the President-Elect position, by adding a stipulation to our Operating Manual.

- P. Thabet explained that first year students at Waterloo miss the deadline to apply for CAPSI president-elect as they start their first year in January and only have the opportunity to apply to president-elect as a second year student.
- R. Ward clarified whether first year students at Waterloo were able to apply to President-Ellect in the previous elections procedure.
- P. Thabet stated that Waterloo students were technically able to apply for President-Elect but did not in practice as they were not yet CAPSI members and first year students did not attend PDW.
- E. Cowley stated that second year Waterloo students are better placed to run for President-Elect as they have had a better opportunity to get involved. She shares that it is difficult to get time off from 4th year rotations to attend the CPhA conference and does not feel that Waterloo students are at a disadvantage.
- J. Yu echoed E. Cowley. and states that there are a lot of changes taking place in their fourth year of studies and is unsure how many students would benefit from allowing third year Waterloo students to run for president-elect.
- R. Ward stated that the playing field is not equal for schools with five year programs as the PharmD program is now five years at MUN, giving them more time to apply within the position.
- T. Sanders stated that any year at a school can be difficult at each school and can involve a lot of transition.

Background Information/Summary: The accountant who was closing our books for 2014-2015-2016 had agreed to do so free of charge as the accountants in Ontario were supposed to provide us with a portion of the completed work (which they had claimed they had done). Unfortunately, they never sent in the documentation so the task of closing the books for those years is quite larger than originally anticipated. As such, CAPSI would have to pay \$3,000.00 to close the books for those outstanding years, which is a fraction of the price that it would cost CAPSI get our new accountants to close the books. Usually, it costs \$7,000.00 to close the books for 1 year. The total for 2014-2015-2016 would be approximately \$21,000.00. Should council want, I can approach our new accounting firm to get a final quote before moving forward with my accountant.

S Châtillon explained the above point and that it is still advantageous for us to have this accountant close our books.

Closing the books for the 2014, 2015 and 2016 was more of a daunting task than was previously expected. To retail cost for closing these books would have been \$21,000.00. Would we be willing to increase the amount we are going to give for completing all this work, closing our books, and filling our taxes for all three years to a total of \$6,000.00 instead of the original \$3,000.00?

- P. Thabet suggested that it is a one time cost. He pointed out that we are still saving the \$15,000 that we would have spent.
- S. Barillaro discussed that an accounting cost was budgeted in the account, but not to the correct firm, so it would even out. He pointed out that our budget is looking much more promising than our original budget had otherwise predicted. He is pleased that the firm took on this challenge on. S. Barillaro explained that although they didn't ask for this payment, previous Finance Officer S. Chatillon suggested that this is a worthy consideration.
- K. MacMillan left the meeting at 9:11pm EST
- R. Ward looked to clarify whether if a motion was passed in the past to provide \$3000 whether that can be changed to \$6000.
- P. Thabet discussed that this would not infringe on Robert's Rules.
