3. Acceptance of Previous Meeting Minutes

T. Rousseaux

4. Membership Fee Taxation

D. Moulton

Background: I have been advised that membership fees are considered taxable income and we should have been charging taxes. I am in the process of determining how to best deal with this new issue in a financially appropriate way that minimizes local council stress/member concerns.

D. Moulton informed council that CAPSI was recently registered for GST and it has been a learning curve. He was informed that CAPSI should be charging taxes on membership fees. Given that the membership drive has been complete, it would not be fair to claw back the money at this point. CAPSI National will absorb the loss. At this time, there is no conclusion, but it's something for juniors to keep in mind and Dylan will update council as soon as he hears from our accountants.

M. Contreras inquired what amount CAPSI National is absorbing.

D. Moulton shared that there is no exact number at this time. He informed that this ranges from 5-15% depending on the province.

M. Contreras asked if there would be an increase in membership fees.

D. Moulton informed that if your province has HST, HST must be charged. If taxes are split as GST and PST then locals only have to charge GST.

T. Rousseaux informed that D. Moulton and her are reaching out to CAPSI's accountants to make a plan for the coming year. She commended D. Moulton for his efforts in ensuring CAPSI's financial sustainability for the future.

5. Advice For Life Certificate Reimbursements

D. Moulton

<u>Background</u>: PharmaChoice has provided council with funds to pay for certificates for winners. We need to discuss how to best manage the purchasing/potential reimbursement process.

D. Moulton informed that it's locals' responsibility to print certificates and frame certificates for which a budget (\$100) is allocated. A budget (\$100) was also provided for advertising which can also be allocated to printing costs. He inquired what the best way for locals to receive the funds would be.

M. Contreras asked for clarification regarding D. Moulton's question about reimbursement.

D. Moulton informed that he will be providing \$200 to locals.

B. Houle inquired what should be done with the funds given that there was no local winner at Waterloo.

D. Moulton inquired if there are any other schools in the same position.

R. Ward shared that when she was a local, local councils received a single cheque for all competition funds from CAPSI National.

M. Kaushal asked if the frames provided to local winners should be given to the winners or put on display at the faculty.

T. Rousseaux clarified that the winners are given the frames to take home.

D. Shymanski asked what should be done with leftover funds from the promotion budget.

T. Rousseaux informed that the sponsors provided the budget for printing and promotions so as to not burden local councils with the competition cost.

6. Update on PDW 2019 Sponsorship

A. Clarke

Background: Sponsorship is currently a big concern for the PDW planning committee. Are there any prospective companies that have gotten back to CAPSI National? Does anyone on council have ideas for recruiting sponsors or companies that should be reached out to?

M. Wei informed that she has looked over the list from PDW Planning Committee, and has contacted companies not on the list but has not received any positive responses as of yet.

D. Moulton suggested that we can create a document on the CAPSI National Facebook group to share any contacts the members of council may have. It would be beneficial to have direct contacts.

T. Rousseaux echoed D. Moulton and informed council that we are not alone in struggles with sponsorship due to the climate of the pharmacy industry.

7. IPSF Health Fair Booth Participation

Background: IPSF typically has a booth at the Health Fair at PDW. Historically, turnout at the booth is not very high due to the reason that we don't have too many free things to give out. Does anyone have any ideas on how to increase turnout at the booth without spending too much money?

S. Terekhovska

S. Terekhovska shared that all CAPSI members are IPSF members, however CAPSI members are not aware of their IPSF benefits. She suggested the possibility of creating a poster with SEP pictures and testimonials.

L. Kotyrba informed that students locally are drawn to ballots and appreciated the idea of a poster with lots of pictures.

M. Contreras suggested conducting an interactive activity with delegates, for example a photobooth.

D. Shymanski shared that videos of student interest can draw in students.

T. Rousseaux echoes M. Contreras and D. Shymanski. She also inquired if there are any students who went on SEP and are attending PDW this year. She suggested it would be a good way for past SEP students to share their experiences and informing students via social media that they will be at the fair.

L. Ford shared that he can help with creating baked goods to draw in students.

M. Contreras shared that cookies and hot chocolate were previously done at UofA for PAM and cost <\$100.

8. IPSF Local Representatives Reserved Seats to PDW T. Rousseaux/ S. Terekhovska Background: At PDW each year, the IPSF Liaison and SEO host a meeting with all of the local IPSF representatives. It is not mandatory for the local IPSF representatives to attend this meeting in person, but they are encouraged to represent their school at this meeting. Currently, it is at the discretion of the local CAPSI council whether to reserve a seat to PDW for their local IPSF representative. For clarity and consistency sake, do locals feel it would be beneficial to have one seat reserved for their local IPSF representative?

M. Contreras asked for clarification regarding what would occur during the meeting, if local IPSF representatives are required to attend and what turnout has been like in the past?

S. Terekhovska shared that she does not have past statistics, however this would be the only opportunity to meet local IPSF representatives in person and set the tone for the upcoming semester. She feels that it would be beneficial to increase IPSF's presence nationally.

D. Moulton echoed M. Contreras and informed that it can strengthen IPSF's relationship among local representatives and CAPSI National.

S. Terekhovska informed that PDW would be the only opportunity to meet local IPSF representatives in person and shared how it would be comparable to CAPSI National meeting at CPhA and PDW.

R. Ward shared that the only concern would be taking away another seat from delegates, however there is value in reserving the seat.

J. Kwon echoed R. Ward.

M. Kaushal inquired what would happen to the reserved seat if the IPSF representative could not attend.

T. Rousseaux informed that if a senior IPSF representative could not go, a junior could go in their place, or another individual who would be able to represent IPSF could attend.

D. Moulton shared that the seat could go back to the school's local pool.

D. Shymanski shared that the IPSF representation at USask has been a lot greater this year given that S. Terekhovska is the IPSF Liaison both locally and nationally. She asked if Council could reserve the seats in the same way that seats are reserved for student body presidents.

T. Rousseaux clarified that the motion in discussion is having CAPSI National reserve seats for IPSF local representatives.

BIRT local IPSF Representatives be reserved one seat for Professional Development Week, effective PDW 2022

9. Approval of Operating Manual Updates by the CRC J. Kwon

A document was sent out to council outlining changes to the Operating Manual for Council to review.

M. Contreras inquired about Advice for Life.

T. Rousseaux clarified that we normally trial new initiatives for 1-3 years prior to adding them to the Operating Manual. However, it would not be an issue to include it in the Operating Manual given that we review the OM regularly.

M. Contreras asked if we should title the outreach programs "Operation:_____" given that TEVA is no longer a sponsor.

J. Kwon inquired if locals still use the kits as some schools still had leftover materials.

M. Contreras asked if the programs could be re-titled to "Outreach Programs"

R. Ward shared that the kits are still used at MUN.

L. Kotyrba shared that the kits are still available at Manitoba, however they have not been used in the last 2 years, but there has been interest in the past. The programs previously qualified for required volunteer hours that first year students are required to complete.

D. Shymanski shared that the programs were modified at USask to combine all presentations into one given that there were not enough materials leftover to carry out the programs as designed.

J. Kwon modified the Operating Manual to reflect that TEVA is no longer a sponsor for the outreach programs organized by CAPSI.

BIRT CAPSI National accept the proposed amendments of the Operating Manual.

10. Secretary Updates

Background: Quick update on membership drive, elections and reminder on position update template.

11. PEBC OSCE Preparation

• Something that many 4th years are always looking for is practice for their OSCE. At UofA, we do have some cases that we have accumulated through the years but new cases have not come up in the past 2 years.

• The Ad-hoc Mock OSCE Committee serves to be responsible for gathering and developing new mock OSCE questions for the bank, developing an assessment template, and having cases reviewed by PEBC as necessary. Being part of it last year, there was no communication with new cases being formed or of a bank that we could use for our members.

• Are there ways we can get new cases every year? Or have a bank where we release X amount of cases per year so that 4th years preparing for their OSCEs can have new material as a good resource and practice? I would like to know how other schools are able to offer this resource if they have any, or if there are ideas out there on how we can approach this.

N. Gajaria shared that a standardized template was created by the mock OSCE committee in the 2016-2017 year.

L. Kotyrba shared that Manitoba has 2 sets of cases that are used for alternating years.

M. Contreras asked if it would be possible for the mock OSCE committee to create 1-2 new cases each year.

T. Rousseaux said that the direction of the mock OSCE committee is at the discretion of the VP Ed. She asked if M. Contreras is looking for cases or looking for someone to host an event?

N. Gajaria

S. Yu clarified that the template is available on the drive and locals can send cases to the mock OSCE committee and they can be formatted to the template that the mock OSCE committee has.

B. Houle shared that Waterloo has a fourth year OSCE. Given that the Senior at Waterloo is in fourth year, the role of creating OSCE cases falls under the Junior's role so that the Senior may participate in their year's mock OSCE event. He also shared that the cases created by the Junior are reviewed by Faculty for accuracy.

T. Rousseaux suggested that it would be great to have CAPSI National create new cases that also incorporate pharmacists' changing scope of practice.

M. Contreras echoed T. Rousseaux and suggested that it would be great for the mock OSCE committee to create a national bank of OSCE cases. It would also be a great CAPSI benefit to add.

S. Yu informed council that she will reach out to the mock OSCE committee in mid-November.

12. Strengthen Relationship with ASP (Academy of Students in Pharmacy) J. Kwon <u>Background</u>: As it is the duty of the President-Elect to act as a liaison between CAPSI and the ASP, are there any topics in particular that you would like me to seek guidance on from ASP? Their resources/initiatives for mental wellness is a subject I would like to touch upon. Are there any other topics?

J. Kwon asked for clarification regarding the status of our relationship with ASP.

T. Rousseaux clarified that last year she reached out to the President of APhA-ASP to touch base on what their organization has been up to and re-introduce our organization. We exchanged annual reports for the previous year but it should be noted that our organizations are structured quite differently.

J. Kwon asked if there are specific topics that council would like brought forward to ASP.

S. Terekhovska shared that she met a member of APhA at World Congress and would be happy to support reaching out to ASP if needed.

M.Contreras reviewed ASP's website, and saw that there were career development opportunities available allowing students to explore different areas in pharmacy such as academia, industry, etc. He suggested that it would be great it we could ask ASP about the logistics of the program as it could be a benefit of interest to our members.

D. Shymanski shared that ASP appears to have a strong advocacy platform after reviewing the website. She shared that it can be a useful resource for our advocacy committee.

J. Kwon echoed D. Shymanski and will reach out to ASP regarding their advocacy platform. He will update council on the result of this initiative at PDW.

13. Advocacy Videos at the Local Level

R. Ward

Background: A student member contacted me to discuss the possibility of locals creating videos similar to this video created by students at Waterloo:

The Ad-hoc Advocacy Committee plans to discuss the idea of producing a national video to launch along with the letter writing campaign during PAM. However, I wanted to bring the idea to the attention of locals if any school is interested in creating one specific to their province. Waterloo created this video around the time of provincial elections, but it doesn't have to focus on that.

M. Contreras commented that at UofA the student body is working with RxA to make a video for PAM and encourages local council to reach out to their respective PPA as this falls in line with the suggested initiative.

T. Rousseaux shared that the videos would be a good venue for us to showcase Pharmacists' full scope of practice and make the community aware of it.

14. Creation of a Document of Local Competition DatesL. Wu/D. Shymanski
Background: Due to misinformation passed down from previous years regarding usual dates for local competitions, this lead to tighter deadlines with the release of competition materials. It would be advantageous to discuss a different system or create a document where locals could

update the usual competition dates for the use of VP Education. This would allow for increased communication between locals and the Competition Review Committee to ensure all parties are given enough time to prepare the competitions and execute them.

T. Rousseaux stated that is difficult for all information to be turned over accurately as we do have frequent turnover for positions. She suggested:

Add to section 3.2.5 of the Operating Manual:

"Responsible for collecting local competition dates following CPhA Conference for the purpose of timing the release of competition materials. Local competitions may include but are not limited to: CAPSI Compounding Competition, CAPSI PIC, CAPSI OTC Counselling Competition, CAPSI SLC, Guy Genest Award, AFL, Pharmafacts."

S. Yu shared that dates were collected informally for some of the competitions and stated that it would be a great idea for this task to be formally added to the VP Ed portfolio.

J. Kwon suggested adding that the dates should be added prior to September of the council year and asked if Advice for Life should be included in the statement at this time.

M. Contreras stated that Advice for Life should not be included at this time in order to be consistent.

Friendly amendment to read:

Add to section 3.2.5 of the Operating Manual:

"Responsible for collecting local competition dates following CPhA Conference for the purpose of timing the release of competition materials before September. Local competitions may include but are not limited to: CAPSI Compounding Competition, CAPSI PIC, CAPSI OTC Counselling Competition, CAPSI SLC, Guy Genest Award, Pharmafacts."

R. Ward shared that locals set the dates of competitions based on PDW registration. Registration dates fluctuate from year to year, and this is something that should be taken into consideration when planning competition release.

Add to section 3.2.5 of the Operating Manual:

"Responsible for collecting local competition dates following CPhA Conference for the purpose of timing the release of competition materials before September. Local competitions may include but are not limited to: CAPSI Compounding Competition, CAPSI PIC, CAPSI OTC Counselling Competition, CAPSI SLC, Guy Genest Award, Pharmafacts."

BIRT CAPSI National approve the above amendment to the Operating Manual.

15. Movember Fundraising Competition

<u>Background</u>: CAPSI could get involved in fundraising for Movember by making it a competition between schools. It could be similar to how we compete in the IPSF blood drive.

N. Gajaria said this has been brought up in previous meetings. Some locals in the past have said that since this is not run through CAPSI but other student groups, there might some conflict. CAPSI can just pass on the information of this initiative to the appropriate student groups.

M. Contreras shared that at UofA the Movember campaign is run by the student council which CAPSI has seats on. He will share contact information for the Movember chair. Contact information for the Development Manager for Movember is Travis Ambing. His email is travis.ambing@movember.com

K. Bishop expressed her support for this initiative. She explained that as UBC movember is not run through CAPSI but speculates that if their local CAPSI council collaborated with the current movember organizers the event could be bigger. She expressed that as healthcare students we should be raising more money/awareness by utilizing this event. She suggested that a possible avenue for fundraising could be cutting hair for donations.

S. Terekhovska echoed that this would be a great idea as the Vampire Cup is very successful in IPSF and competition often drives the initiative and contributes to unity.

16. Support for Local IPSF Representatives

S. Terekhovska

<u>Background</u>: Some IPSF Local Representatives have suggested organizing a bake sale to fund student(s) going on exchange or attending an IPSF event. This isn't mandatory, but some support may be required if your IPSF local representatives approach you with a plan of doing this at your school. Please note that the money would then be managed on a local level.

S. Terekhovska shared that students going on SEP would still have to apply for the funds, and the funds would be managed by CAPSI local council. She stated that this idea has already been run by her, and would encourage locals to support their IPSF representatives if they would like to take on this initiative.

17. International Conferences

S. Terekhovska

<u>Background</u>: Applications to register for World Congress, Pan American Regional Symposium and World Health Assembly usually open up around January. Are any executives/locals planning to attend any of these events? Or have you been approached by students in your school that have expressed interest in these events?

S. Terekhovska shared that the World Health Assembly takes place yearly in late May in Geneva at the WHO Headquarters.

J. Kwon asked for clarification on the differences between World Congress, PARS and World Health Assembly?

S. Terekhovska shared that World Congress is the most significant event where the decisions affecting students internationally takes place. PARS is the Pan American Regional Symposium, where delegates from North and South American countries meet and make decisions for the upcoming year. World Health Assembly (WHA) typically occurs in late May, when IPSF sends a delegation to the WHO headquarters in Geneva, Switzerland. At WHA, IPSF delegates deliver a series of position statements that emphasize the role of pharmacists in the healthcare systems worldwide.

18. IPSF Activity Reports

<u>Background</u>: I have created a schedule of activity reports – each school should provide at least two reports per year. Please note that the CAPSI Local Jr/Sr may be listed as the activity coordinator, and if there are any questions on the report from other Contact Persons, then I will either get in touch with the activity coordinator directly, or ask the IPSF Local Representative to get in touch with you to answer the questions.

19. CSHP Student Delegate

K. MacMillan

S. Terekhovska

See below for a list of events that would are in the terms of reference and we are planning to encourage hospital student representatives to organize or help to organize. However, organizing additional events is encouraged. <u>I would like to discuss the Evidence Based Practice</u> <u>Competition, specifically, to see if there is a way for all hospital student representatives from the different faculties to be involved and help the CAPSI representatives organize it next year.</u>

A. Membership Drive:

Invite a hospital pharmacist who is a member of the CSHP to explain what CSHP is, and share a bit about their practice.
 Students may be invited to talk as well. The CSHP representatives or presidential officer presents the advantages of becoming a

student member. This event is usually held between September and October.

B. Evidence Based Practice Competition (CAPSI event):

i. This is a national evidence based medicine competition that is hosted in cooperation with CAPSI. Teams of between 2 and 4 people are allotted 2 hours to solve a clinical case. The winning team receives a CSHP student/newly graduated pharmacist membership for one year. Contact your CAPSI Junior/Senior for more information and to get involved.

C. CSHP Hospital Residency Night:

i. Typically, this event is organized by the local CSHP branch, but the CSHP Student Representatives can help with the event. Hospital pharmacists or residents talk to the students about what a hospital residency entails, and how to apply.

D. CSHP Student Symposium (Career Night):

i. Purpose: to give students exposure to the opportunities becoming a hospital pharmacist offers. It also gives students the opportunity to meet local hospital pharmacists.

ii. Work with the local CSHP branch to find hospital pharmacists to speak about their experiences and the benefits of being a hospital pharmacist at the event. It is recommended to supply food for the event, as it serves as an extra incentive for students to attend.

Why did we create the new Terms of Reference?

The intent of the recommendation: Improve the governance model whereby the CSHP Board approves the terms of reference document (created by the Student Delegate and sent to all CSHP student representatives for approval outlining the recruitment, selection, and responsibilities of branch student representatives with hospital student representatives).

The connection between the recommendation or item for consideration and the Society's Strategic Plan – at the goal level. Member and Volunteer Engagement: Would help students understand recruitment processes, which may increase willingness to volunteer for hospital representative positions. Would help to address the inconsistency of student representative duties and recruitment between the branches, which may limit standardized provincial collaboration in the student sub-committee as well as collaboration with CAPSI. *Benefit*: A standardized guide would assist student representatives and inform them on how best to involve students at their branch and promote membership. *Who is responsible for the action?* Student Delegate and the CSHP National Board.
